Aviation System Action Program

The program continues to develop and mature. Feedback from our stakeholders has been key. ODA continues to recognize the impact ASAP can have on the aviation industry in Oregon and hopes to continue to deliver outstanding service in all three programs.

COAR: ODA staff will be working with airports to complete requests for reimbursements and inspections for projects.

We are encouraged to see quick and successful projects this year and are looking forward to being in the communities.



Rural Oregon Aviation Relief Program (ROAR):

In April 2017, ODA and Klamath Falls Airport resolved an important and useful ROAR grant for marketing. We are excited to work with a rural community on their expanding air service and the much needed marketing funds.

State Owned Airport Reserve Program (SOAR):

The Aviation Board has approved a total of 18 projects with a combined budget of over \$1.4 million for state-owned airports! Planned projects include equipment purchases, several obstruction removals, a runway reconstruction, and more.

Precision Approach Engineering was awarded a 5 year contract with the Department through the SOAR Program for design and engineering projects at non-federally funded state-owned airports. These airports are not a part of the National Plan of Integrated Airport Systems (NPIAS) and thus do not receive federal funding.

“The National Plan of Integrated Airport Systems (NPIAS) identifies nearly 3,400 existing and proposed airports that are significant to national air transportation and thus eligible to receive Federal grants under the Airport Improvement Program (AIP). It also includes estimates of the amount of AIP money needed to fund infrastructure development projects that will bring these airports up to current design standards and add capacity to congested airports. The FAA is required to provide Congress with a 5-year estimate of AIP eligible development every two years” (Federal Aviation Administration). Gearing up for the second COAR Grant Cycle!

Get ready for the second COAR Grant Cycle!

This will be the first year applicants will use our e-Grants software. ODA went through months of development and testing with Agate Software, Inc. to develop this final product. **Thank you to the airports and consultants that volunteered to participate in testing!**

ODA is currently in the process of backfilling data from

the 1st grant cycle into the software.

What this means for you? Applicants who submitted a 2016-17 COAR grant application will have the option in the software to copy-forward the information into the 2017-18 application! This is beneficial for applicants that did not receive funding and want to apply again this year for the same project.

Applicants who applied in

2016-17 will receive login credentials for e-Grants from ODA Program Coordinators in mid to late August.



You may be asking yourself, “Now what?” after submitting a COAR grant application. Lucky for you, we have a timeline to show the life cycle of an application for the 2017-18 grant cycle.

Please keep in mind, meeting dates are subject to change. All public meetings will be noticed on the ODA website. Applicants and parties signed up to receive e-mail notifications will receive meeting invites to the events.

Tips to get started

Federally funded projects:

- ✦ Make sure the project is listed on your CIP letter from the Seattle AOD.
- ✦ Please have an up to date project cost estimate on all forms.
- ✦ Communication is key! Talk to your consultant, ODA SCIP Coordinator and the FAA to

make sure all are on the same page.

- ✦ Apply for projects that will start in the next federal fiscal year. This means 2018 projects!

All projects:

- ✦ Submit applications as early as possible.

- ✦ Be prepared! This applies to all stages of the cycle.
- ✦ Don't be afraid to ask questions. ODA is here to help!
- ✦ Become familiar with the e-Grants software.
- ✦ Apply! Even if you think the likelihood of getting funded is minimal, ODA encourages your application so that ODA can present an accurate story to better prepare for the future.
