COAR Program: or Critical Oregon Airport Relief program, is described in 2019 Oregon Laws, chapter 485, section 1(5). Grant cycles occur annually in the fall. The fifth grant cycle received applications October 1 through October 23, 2020. Final selection by the State Aviation Board for grant funding was at the February 4, 2021 meeting.

SOAR Program: or State Owned Airport Reserve program, is described in 2019 Oregon Laws, chapter 485, section 1(7). Each cycle consists of two calendar years. Third cycle projects were approved by the State Aviation Board in February 2020. Note, the State Aviation Board approved a Contingency Fund in each cycle for small projects; each small project has been counted as an individual project in the table below. Projects in cycles 2 and 3 have been canceled or delayed due to decreased revenues during the COVID-19 pandemic.
