



## Executive Summary on HB4109 (2024)

The Oregon Department of Aviation (ODAV) is pleased to submit this report under ORS 319.023 with details regarding applications for distribution of fuel tax revenue for the Aviation System Action Program Fund (ASAP). **ASAP PROJECT UPDATES:** Project information is listed in the COAR Status Report 07.17.2025, SOAR Status Report 07.17.2025, and ROAR Status Report 07.17.2025.

**COAR Program:** or Critical Oregon Airport Relief program, is described in 2021 Oregon Laws, chapter 526. Grant cycles occur annually in the fall. The ninth grant cycle received applications October 7 through October 25, 2024. Final selection by the State Aviation Board for grant funding was at the February 6, 2025 meeting. Cycle 10 (2025-2026) is scheduled to open for grant applications in October 2025.

All projects in COAR cycles 1-4 are completed and the grant cycles are closed. Open grants in COAR cycle 5 are nearing completion and expected to be closed out within the next 12 months. COAR cycle 6 has 8 open grants with the majority expected to be completed within 12 months. COAR cycle 7 has 15 grants in progress, with most expected to be completed in 12-18 months. COAR cycle 8 has 35 grants in process and six grants pending execution, and cycle 9 grants approved in February 2025 are in the process of being executed. ODAV will continue to work with grantees to execute current awarded grants to complete as many as possible before the 2025-2026 COAR cycle.

**SOAR Program:** or State Owned Airport Reserve program, is described in 2021 Oregon Laws, chapter 526, section 1(7). Each cycle consists of two calendar years. The State Aviation Board approved a Contingency Fund in some cycles for small projects; in Cycle 1 only, each small project was counted as an individual project in the table below. Projects in cycles 2 and 3 were delayed due to increased project costs and decreased fuel tax revenues during the COVID-19 pandemic. Projects in Cycle 4 include contingency and worker funds and re-approval of past cycle projects by the State Aviation Board. Cycle 5 projects include contingency and worker funds, Oakridge Airport runway reconstruction, and purchase of obstruction removal equipment. The 2024-2025 cycle projects were approved by the State Aviation Board at the February 1, 2024 Board Meeting.
