- ▶ 2025-26 Received 66 applications with total ask of almost \$5.9M

- ▶ 2024-25 Received 58 applications with total ask of almost \$6.5M

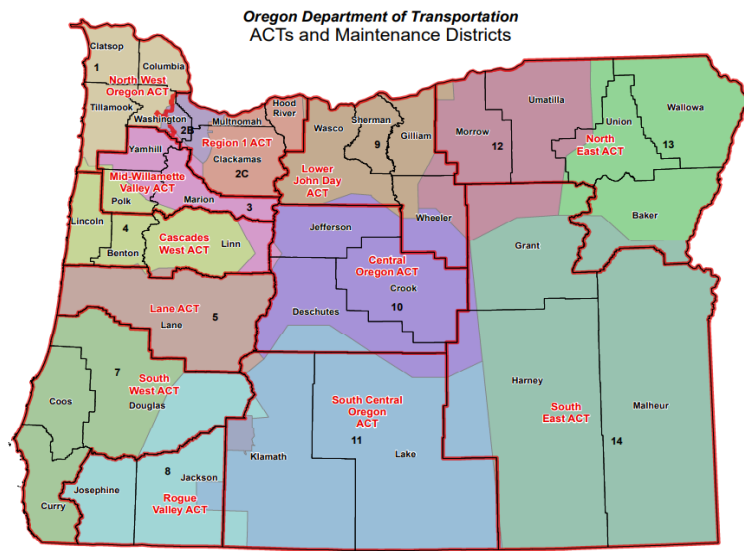
# Aviation Review Committee

ORS 319.023(3)(a)

"The State Aviation Board shall establish a review committee composed of one member from each of the area commissions on transportation chartered by the Oregon Transportation Committee."

## ARC Member Selection

- ODAV requests the Area Commissions on Transportation (ACTs) nominate a member from each ACT to serve on the Aviation Review Committee (ARC).
- List of ARC members submitted to the State Aviation Board for approval.



## ARC Review Process

- ARC members are put into groups or cohorts of 2-3 and given a packet of COAR applications to score.
  - ARC members do not score applications from their own ACT region.
  - If the ARC member is an applicant, they do not score their own applications.
- ARC members use criteria established in ORS 319.023 to score grant applications.
- All ARC members are provided list of scored applications for review, and meet as a full group to create list of recommended projects for State Aviation Board approval.
