

1 (2) Under ORS 479.620(1), subject to ORS 479.540, a person may not advertise or purport
2 to be an electrical contractor, without an electrical contractor's license.

3 **STIPULATED AGREEMENT**

4 Respondent and the Boards agree to resolve this matter, without a hearing, by the entry of
5 this Consent Order subject to the following terms and conditions:

6 (1) The Plumbing Board hereby assesses a civil penalty of \$3,000 for violating ORS
7 447.040(1), of which \$2,750 will be suspended for a period of five years under the following terms:

8 (1.1) Respondent agrees to pay the remaining \$250 of the civil penalty.

9 (2) The Electrical Board hereby assesses a civil penalty against respondent of \$3,000 for
10 violating ORS 479.620(1), of which \$2,750 will be suspended for a period of five years under the
11 following terms:

12 (2.1) You agree to pay the remaining \$250 of the civil penalty.

13 (3) The \$500 civil penalty will be paid in 5 monthly payments of \$100 each. Payments will
14 be due the **25th of the month. (An invoice will be included with the Respondent's copy of the
15 Final Order after it is signed by the Board.)**

16 (3.1) You will send a \$100 payment to The Department of Consumer and Business
17 Services Fiscal Services Section, PO Box 14610, Salem, OR. 97309-0445 **no
18 later than**

- 19 3.1.1 October 25, 2013
- 20 3.1.2 November 25, 2013
- 21 3.1.3 December 25, 2013
- 22 3.1.4 January 25, 2014
- 23 3.1.5 February 25, 2013

24 (3) You agree not to commit further violations of Building Codes Division's statutes or
25 rules.

(4) You understand that if you fail to comply with any of the terms of this consent
agreement, including failure to make a payment under this order within 10 days of due date, that the
entire civil penalty, including the amount suspended, will be immediately due and payable. Failure
to comply includes failure to pay the civil penalty amount on the Final Demand Notice by the due
date, or failure to make payments according to the terms of any payment arrangement or Final
Demand Notice.

(5) You understand and agree any violation of the terms of this Consent Order will result in
further enforcement action.

2 (6) You understand and agree that any violations of Building Code Division's statutes or
3 rules not alleged in this Order, whether committed before or after the execution of this Consent
4 Order, may be the basis for further enforcement action.

5 (7) You understand the suspended civil penalty will be waived five years after the execution
6 of this Consent Order, provided you comply with its terms and have not committed any further
7 violations of Building Codes Division's statutes or rules.

8 (8) You have read and fully understand the terms of this Consent Order, freely and
9 voluntarily consent to the entry of this Order without further hearing, without any force or duress,
10 and expressly waive all rights to hearing or appeal in this matter.

11 (9) You understand that, upon signature of all parties, this Consent Order will be a FINAL
12 ORDER.

13 (10) You further agree by signing this Consent Order that you are the Respondent or
14 authorized representative for the Respondent in this matter.


