9 The Director of the Department of Consumer and Business Services (Director),
10 Building Codes Division (BCD), and the Boiler Board of the State of Oregon are the
11 entities responsible for licensing, regulating and disciplining boiler installers, boiler
contractors, boiler contracting, and boiler installations in the State of Oregon.

12 2.

13 On or about May 20, 2013, the Respondent submitted an application for an Oregon
14 Boiler Contractor license. This Stipulated Order is an agreement to issue a Boiler
15 Contractor license to the Respondent including the right to any hearings, appeals, or
judicial reviews.

16 3.

17 Respondent and the Director desire to enter into this Stipulated Order.
18 Respondent understands that he has the right to a contested case hearing under the
19 Administrative Procedures Act (Chapter 183), Oregon Revised Statutes, and fully and
20 finally waives the right to a contested case hearing and any appeal there from by
signing and entry of this Order in the Director's record. Respondent understands that
this Order is a public record.

21 4.

22 Respondent and the Director agree to resolve this matter, by the entry of this
23 Stipulated Order conditioning Respondent Boiler Contractor's license no. BB174
subject to the following terms and conditions:

24 4.1 If Respondent violates any provision of Oregon Building Codes statutes,
25 administrative rules, specialty codes within three years of the execution of this
Stipulated Order, the Boiler Contractor's license no. BB174 may be revoked
without appeal.

2 4.2 Respondent has read and fully understands the terms of this Stipulated
3 Order, freely and voluntarily, without any force or duress, consents to the entry of
4 this order and expressly waives all rights to a hearing, appeal, or judicial review in
5 this matter.


6 4.3 Respondent understands that, upon signature of all parties, this Stipulated
