9 The Department of Consumer and Business Services, Building Codes Division (Agency) licenses
10 and regulates plumbers, electricians, plumbing and electrical installations in Oregon, and promulgates and
11 enforces the Oregon Specialty Codes.

13 On or about July 10, 2014, the Electrical and Elevator Board of the State of Oregon (the "Electrical
14 Board"), and the State Plumbing Board of the State of Oregon (the "Plumbing Board") properly served upon
15 Respondent a Notice of Proposed Assessment of Civil Penalty and Final Order on Default and Order to
16 Cease and Desist (the "Notice"), alleging violations of Agency's Oregon Revised Statutes and Oregon
17 Administrative Rules. Respondent denies the allegations contained in the Notice and timely requested a
18 hearing on the matter.

20 On or about November 13, 2014, the Agency properly served upon Respondent an Amended Notice
21 of Proposed Assessment of Civil Penalties and Final Order on Default and Order to Cease and Desist (the
22 "Amended Notice"), alleging violations of Agency's Oregon Revised Statutes and Oregon Administrative
23 Rules. Respondent denies the allegations contained in the Amended Notice and timely requested a hearing
24 on the matter.

2 Consent Order.


4 Respondent stipulates and agrees that this Consent Order is fully executed and becomes effective the


8 Respondent understands this Consent Order is a Final Order and a public record. By its signature
