2. Return this citation to Building Codes Division **within 20 days** from the date it was served. (See front of citation for date of service).

Notice: If you do not request a hearing within 20 days, this citation will become a final order, effective 21 days after it was served. If you do not request a hearing or if you fail to appear at a scheduled hearing, the division's file on the matter becomes the record. You are entitled to judicial review of this order. Judicial review may be obtained by filing for review within 81 days from the date this order was served. Judicial review is pursuant to the provisions of ORS 183.482 to the Court of Appeals.
