## 2018 International Fire Code Construction Provisions

### Section Location Guide

The 2019 Oregon Structural Specialty Code (OSSC) includes portions of the 2018 International Fire Code (IFC) that apply to the construction, reconstruction, alteration, repair and installation of materials and equipment in or a part of buildings and structures governed by the state building code.

This guide is intended to help the code user locate IFC construction provisions within the 2019 OSSC. This guide is intended to serve as a summary of major sections and does not include every subsection integrated.
