

iOS Oregon Inspector App Release Notes, Version 1.0.24

Released October 14, 2021

1. Google Maps Available on IOS Version – Enhancement

Requested by: Coos County

Enhancement: It was requested that the app allow users to use Google Maps instead of the native Apple Maps on their IOS devices. Users can now choose either Apple or Google Maps as the default for the Inspector App. If Google Maps is installed on your device when you touch and address in the app it will automatically open the Google Maps App. If you do not have Google Maps installed on your device it will automatically open your web browser to Google Maps.

Instructions: Touch the “Menu” button and then choose “Settings.” Next choose “Manage Maps” and select either Apple or Google Maps.

2. Inspection Summary Report – Pictures not attaching

Reported by: Coos County

Issue: When attaching pictures to an inspection report it was reported that they were not appearing on the Inspection Summary Report when touching the “View Report” button and then accessing the Inspection Summary Report. As a workaround users can access the Record for the inspection and then view the “Documents” section where they will see the Inspection Summary Report and the pictures attached as a document. This error occurred in Version 10.1.22 and has been resolved.

Fix: Pictures now attach and show up on the Inspection Summary Report when touching the “View Report” button after resulting and inspection.

3. Enhancement – Owner name now on Inspection Summary Report

Requested by: Malheur County

Enhancement: It was requested that the Owner Name be added to the Inspection Summary Report as it is required information for utilities in some cases.

Fix: The Inspection Summary Report (first option of four on app) now includes the Owner Name.

4. Multi-Select Reschedule – Erased inspection request comments and contact information.

Reported by: Oregon ePermitting

Issue: When using the multi-select tool to reschedule inspections the app erases all of the request comments and provides the option to add new contact and comments info instead keeping the original request comments and contact info when rescheduling.

Example: an inspector has 10 inspections scheduled for today, but is sick and needs to reschedule all of their inspections to the following day. To keep the existing comments they would have to reschedule them all individually.

Fix: ??????

5. Save Option for Documents – Not available to some users.

Reported by: Happy Valley

Issue: Users have the ability to save record documents directly to their device. Users where attempting to save plan documents to their iPads, but were unable to complete the save function.

Fix: The app has been updated to allow users to save documents from Records within the app to their iPad or iPhone. This started occurring in version 1.0.15

6. Inspection Reports Updated – Enhancement

Requested by: BCD

Enhancement: We have removed the “Android Inspection Report” on the iOS version as it was a blank report. We have also updated the Inspection Summary Report which is the first inspection report on the list to reflect that it is the report with pictures attached.
