To: All Active Commercial Oregon certified inspectors and/or plans examiners
RE: 2025 COMMERCIAL CODE CHANGE CONTINUING EDUCATION INFORMATION

All persons holding one or more active commercial certifications issued prior to October 1, 2025 are required to take a code change class provided by Oregon Building Codes Division (BCD) to maintain their active certification(s). Code change training is offered online, in an electronic format.

Certifications that require the 2025 Oregon BCD Code Change class:

- Oregon Structural Specialty Code (OSSC): SIA, SIB, PEA, PEB, and PEF.
- Oregon Mechanical Specialty Code (OMSC): MIA and MIB.
- Oregon Energy Efficiency Specialty Code (OEESC)) must be taken by individuals who hold one or more of the following certifications: SIA, SIB, PEA, PEB, MIA, and MIB.

You must complete the required code update training and self-certification by June 1, 2026. Self-certification forms received and dated after June 1, 2026 will result in certifications expiring.

- **Oregon Administrative Rules for inspector continuing education:** (OAR) 918-098-1450.
- **How are the classes accessed?** Visit the BCD website at www.oregon.gov/bcd, click on the “Renewals and code change” link found on the home page under the “Inspector” information box.
- **What is the class fee?** There is no fee for viewing the virtual classes or material.
- **What credit is given for completing a BCD code change class?** Completing required code change instructional videos and submitting the self-certification form to BCD satisfies the continuing education requirement(s) for certified building inspectors and plans examiners in Oregon. Completion of the videos does not generate credits for continuing education for trade license holders or for national certifications.
