ASWB—MASTERY TEST TAKING COURSE

The ASWB program: Mastery Test Taking is highly recommended for all test takers, or if you have previous difficulties with anxiety or testing anxiety. This program is no test specific, but helps you prepare your mindset for taking an important test. This program is free for all of those that are interested in participating.

Launched in January 2023, ASWB began parting with FifthTheory, a minority-owned firm with expertise in high-stakes testing

and occupational assessment. You can find additional information on the ASWB website: https:// www.aswb.org/mindset-resources-to -be-offered-to-all-aswb-test-takers/.

When exam candidates register for their exam, their Authorization to test email invites them to access the FifthTheory Test Mastery Inclusion Program. The program starts with a self-assessment. If candidates choose to participate, they will receive an individualized report with information and insights to help them prepare for their ASWB exam. Participants will also receive a test mastery coaching guide, a guided journal and access to a self-interpretation webinar and positive affirmation audio

CONTINUING EDUCATION

All Continuing Education is required to be completed BEFORE the last day of your renewal date, which is the last day of your BIRTH MONTH. Your expiration date is 30 days after your renewal date. You may still renew during your expiration month with a late fee, but only if you have already met the continuing education requirements prior to your renewal date. Renewals are not available in the portal until CE requirements have been met. If you have submitted your renewal, and are audited, you may be charged a fee if your renewal is submitted incomplete.

Please make sure to familiarize yourself with and utilize our website, https://www.oregon.gov/blsw/Pages/index.aspx. Continuing education information and requirements can be found here, https://www.oregon.gov/blsw/Pages/. ContinuingEducation.aspx. Please note, CSWAs and new licensees renewing for the first time do not need CEs and there will be no CE portal option.

Licensees can upload CEs at any time. You may use the full two years reporting period to spread out the trainings. When you complete a training, enter it into the continuing education portal immediately. This will file it in your portal, keep a running total for you, and have it done and ready for you when you renew. If you cannot accurately complete the fields in the portal by looking at the certificate of completion, the training may not be appropriate or approved for social work CEU licensure.

To fit within our Ethics requirement, the CE needs to be related to Professional Boundaries, Confidentiality, Dual Relationships, Legal or Law course, and Mandatory Reporting topics. Cultural Competency is a range of cognitive, affective, behavioral, and linguistic skills that lead to effective and appropriate communication with people of other cultures and lifestyles.

If your workplace requires you to take trainings, or offers trainings through an independent program, sponsored by your agency, and the trainings otherwise fit our rules for types of continuing education (see OAR 877-025-0006) you may claim up to half of your requirements using Agency Sponsored In-Service Activity. Do not use Continuing Education approved by other State Social Work Boards unless your certificate provides a particular state social work board. These two options are not catch all categories. They are specific and the certificate should identify why you have selected that option.

CE TAKEAWAYS

- Renewal Date—Last Day of Licensee's Birth Month
- Expiration Date—30 Days following Renewal Date
- Begin Renewal—up to 45 days prior to Renewal Date

HELPFUL CE TIPS

When submitting your continuing education, you can make sure that your CE certificates will meet continuing education requirements by:

- Double checking your certificate is labeled with the type of credit it is (i.e.: Cultural Competency, Ethics, etc)
- Always double check if your CE has the approved credentialing body listed
- Make sure your certificates have clearly defined or identifiable number of credit hours
- Double check that the date of your certificate falls within your renewal period

BOARD CHAIR LETTER

I imagine everyone is happy to have more daylight and warmer weather! I know I am looking forward to many outdoor activities on my calendar.

The future of social worker licensing is front and center this year as the Social Workers Compact is moving across the country, with more than 24 states enacting legislation.

After the Compact's inaugural meeting on Sept 17, the Compact Commission will continue to work on operationalizing the Compact, including acquiring a data system. The data system is a foundational piece of compact operations, where member states communicate licensure information with each other and with the Compact Commission. Their third meeting in Feb included establishing bylaws that will govern the Commission.

Once the data system is operational and the commission has finalized all necessary rulemaking, applications will be made available for social workers to apply for a multistate license that will allow social work practice in all other member states of the compact without any further steps necessary.

Oregon has a current House Bill that is working its way through legislation.

Oregon Board of Licensed Social Workers and their staff are committed to issuing provider numbers for any application type in an efficient manner. We are excited to announce that all application types are being issued their provider number within 30 days from the date a complete application is submitted! When submitting your applications, please make sure that your contact information is up-to-date and as this is how we will communicate with you and send you your provider number information.

OHA Rule Change:

OREGON BOARD OF LICENSED SOCIAL WORKERS

The State Board of Licensed Social Workers was created in 1979 by the Legislature, and is authorized by ORS 675.510-675.600.

The Board of Licensed Social Workers (Board) is statutorily responsible to protect the citizens of Oregon through the regulations of social workers. This is accomplished through setting policy, establishing standards of practice and ethical conduct, establishing standards for certification and licensure, including renewals, and monitoring continuing education requirements.

ABOUT THE BOARD AND ITS MEMBERS

The Board is comprised of 7 members, appointed by the Governor, and confirmed by the Senate. Three members must be licensed clinical social workers, one must hold one of the other three social worker licenses, and other three must be members of the public and not be licensed social workers.
