### 7. EXECUTIVE DIRECTOR'S REPORT:

**Harnisch** provided a technology update. Board staff continue to have weekly conference calls with Thentia's project managers and developers. The product is getting close to having a go live date. The Board's contract with payment processor NIC USA is currently being reviewed by DOJ for approval. Harnisch is looking at June for a go live date.

**Harnisch** provided a 2019-21 budget update. Harnisch put in an increase request in the February short session to fund the limited duration Investigator 2 position through the rest of the biennium. Due to senate members not returning, the bill died. The Board's request will likely go to the E-Board.

**Harnisch** provided a 2021-23 budget development update. Harnisch does not anticipate the Board's revenue decreasing. The Board's flat rate agreement with DOJ will be discontinued in the next biennium, and will move to the standard hourly rate for DOJ services. Harnisch is going to build in a policy option package for the limited duration Investigator 2 position which is an additional amount above current service level for the 2021-23 biennium.

- Outland moved to direct Randy Harnisch to file temporary amendment to OAR 877-001-0020 to allow the Board to waive late fees upon written request for any licensee during a disaster or emergency declared by the Governor for a time period of 180 days.

Jensen moved to direct Randy Harnisch to file temporary amendment to OAR 877-020-0010 to allow all supervision to be conducted via electronic video conference or telephone with no requirement for in-person meetings during a disaster or emergency declared by the Governor for a time period of 180 days.

- iii. Motion passed unanimously.
