#### 1. CALL TO ORDER

Chair Rasmussen called the Board Meeting to order at 8:04 a.m. and announced that Dehaan was excused from this meeting. Rasmussen determined that Vice Chair Price and Board members Oldham, Rain and Zancanella had joined the conference call and that therefore the Board had a quorum to conduct business.

#### 2. REVIEW/APPROVAL OF AGENDA

Chair Rasmussen requested that a motion be made to remove all items from the agenda except for the Approval of the Proposed Consent Agenda. Zancanella moved to adopt the agenda for the Board meeting as amended. Oldham seconded. The motion passed unanimously.

#### 3. APPROVAL OF CONSENT AGENDA

Chair Rasmussen asked if any amendments were necessary to the Consent Agenda. Pittioni reported that several additional persons had completed requirements to be placed on the Consent Agenda since the draft Consent Agenda had been e-mailed to the Board. Pittioni added that the criminal background check LEDS system had shown additional completed criminal records checks at 7:30 a.m. and those applicants would benefit from being added to the Consent Agenda before mandatory licensure for clinical work would commence on January 1, 2011.



Pittioni reminded Board members that notwithstanding the large number of new applicants on the Consent Agenda Board staff was operating on a different holiday schedule and would ensure that new licenses and certifications approved by the Board would be issued and mailed by close of business on December 31, 2010, as well as be reflected on the Board's web site. Pittioni asked Johansen to read the additional names to be added to the draft Consent Agenda. Johansen advised that Andrew Delgado, Marietta Dyer, Lavonne Tjoelker and Rachel Cochenour had completed their CSWA application files and should be added, and that Catherine Alder and Patricia Butler had completed their LCSW application files and should be added.

Chair Rasmussen announced that since she did not have access to a written Consent Agenda she would need to abstain from voting. Vice Chair Price moved to adopt the Consent Agenda as amended. Rain seconded. Price, Oldham, Rain and Zancanella voted yes. Chair Rasmussen abstained. The motion passed unanimously.


