NEED FOR THE RULE(S):

Adoption of this rule is needed to allow Board to request that the Department of Corrections give an adult in custody who was deferred for release, counseling services.

JUSTIFICATION OF TEMPORARY FILING:

This rule would specify that after deferral of an adult in custody's (AIC) release, denial of an AIC's re-release onto parole after a future disposition hearing, or after deferral of an AIC's right to petition the Board for a hearing under OAR 255-032 and OAR 255-033, the Board may request DOC to consider providing correctional rehabilitative services to that AIC. This rule is needed for creating a new process to request from the Department of Corrections that those AICs be considered for correctional rehabilitative services consistent with the Department's administrative rules and policies. So, this is an urgent issue. The longer this takes to be implemented, the more AICs deferred by the Board may not receive consideration for additional correctional counseling services provided by this request.

RULE SUMMARY: Adopting this rule will allow the Board to request that the Department of Corrections provide correctional rehabilitation services to adults in custody that the Board defers.

CHANGES TO RULE:

Communication to Department of Corrections Upon Deferral

The Board may, after issuing an order deferring an adult in custody's release under this rule, denying re-release onto parole after a future disposition hearing under OAR 255-075-0096, or upon deferral of an adult in custody's right to petition the Board for a hearing under OAR 255-032 and OAR 255-033, request the Department of Corrections provide correctional rehabilitative services, consistent with the Department's administrative rules and policies.
