CALL TO ORDER

The meeting was called to order at 7:00 p.m. by Chair Edwards after a roll call quorum was established. Due to the COVID-19 epidemic, the meeting was held via Zoom.

RULES:

Williams moved to adopt the proposed rules regarding Board compensation, professional development, and temporary licenses for military spouses as final. The motion was seconded by Ooley. The motion passed unanimously.

Martin moved to propose the rules regarding Governor's executive orders for permanent rule making. The motion was seconded by Williams. The motion passed unanimously.

BUDGET REPORT:

Earlier in the day, the Governor released her budget which calls for the Board to be placed under the Oregon Health Licensing Office (HLO), a division of the Oregon Health Authority (OHA). The plan would be for the agency budget, staff, and program to move to HLO in the second year of the next biennium (July 1, 2022) which would allow transition planning to occur for the first year of the biennium. Haag said that the most important factor will be that the Board maintains its independent statutory authority to regulate the profession. Haag will keep the Board informed.
