AGENCY REPORTS:

Chris Huntington,

Updated on the 2025-27 Fiscal Summary. Reviewed the Rates of renewals from 2024 to 2025.

Updated on the License System replacement project, CCB continues to prepare for the procurement and implementation of a License and Enforcement System Modernization. The scope of the Licensing and Enforcement System Modernization is to replace all disjointed systems currently being used and provide one system where staff can see the entire history of a license including documents uploaded related to a license.

Dana Zeimantz, Licensing Manager reported

General Highlights:

For the last quarter, Licensing issued an average of 400 new licenses per month and renewed an average of 1,662 licenses per month.

Project Update:

- Licensing staff continue to participate in reviewing decision briefs, software requirements and developing use cases for the upcoming system replacement. This now includes data clean up in preparation for data migration to new software.
- In Progress: Currently testing new software for call center staff as we continue to look for ways to improve connectivity and refine call center productivity. If successful, all call center staff will utilize the new software in the next 4-6 weeks. Proceeding with testing.

Noel Magee, IT Manager reported

The new system replacement activities continue and the RFP has been forwarded to the approving authorities at DAS, DOJ, etc. We expect a few rounds of corrections prompted by the reviews before the RFP can be released.

Move to SDC:

- 1) Production servers moving to SDC. **Completed**
- 2) Move all staff to DAS F5 VPN, decommission old CCB VPN. **Completed**
- 3) Move CCB network from current to the state Ring service. **Expected Completion 10/11/2025**
- 4)

Rollout Windows 11:

- 1) We will do this in a group-by-group fashion.
- 2) First group (education) to shake out the process **Completed**
- 3) Most of the workstations will be moved in the next two weeks so all but a few stragglers should be done by the board meeting. **In Process, will complete on or shortly after October 15.**

This Licensing System Replacement:

- 1) documenting current business processes so they can be more easily configured in whichever new software is eventually chosen is a heavy lift. This activity will pay back with more time and effort savings as the project moves forward. **In Progress**
- 2) Software development to implement the retention specifications during this period although it will take some months to complete. **In Progress**
- 3) Documentation under review for SG2 approved by procurement, security still pending. **In Progress**

We're reporting good numbers on the Security metrics.

➤ **Security reported status - Reported monthly by EIS/Enterprise Security Office (ESO)**

- ◆ EIS is moving everyone to "Tenable One" which is a newer, enhanced security software. The old Tenable was used to generate these numbers in the past.
- ◆ During the move to new Tenable, they cannot generate those reports.
- ◆ Even after the Tenable move is completed EIS expects it could take a few months to begin generating reports again.
- ◆ **09 June 2025**
 - 100% of systems scanned (statewide 87%)
 - 1% have critical vulnerabilities (statewide 23%)

A busy summer leads into a busy fall season in the CCB education section. CCB has several exciting events coming up in the next few weeks, including:

- We will be hosting our first 3-hour Spanish webinar at the end of this month, on October 29. Over 90 contractors have signed up and that number increases every day.
- On October 15, we will hold our second Weatherizing webinar aimed at homeowners. This is a repeat of the Weatherizing webinar we held last year at this time. 70 people attended last year's webinar, and we're expecting a similar turn out this year. 178 people are currently signed up as of the time of writing this board memo.

In addition, we've finished planning for the 2026 Home Improvement Month, and in the coming weeks we'll be reaching out to state agency partners to invite them to participate. We are also currently putting together a schedule for Spanish webinars on How to Get Your License – this will be the counterpart to the webinars we've been hosting in English.

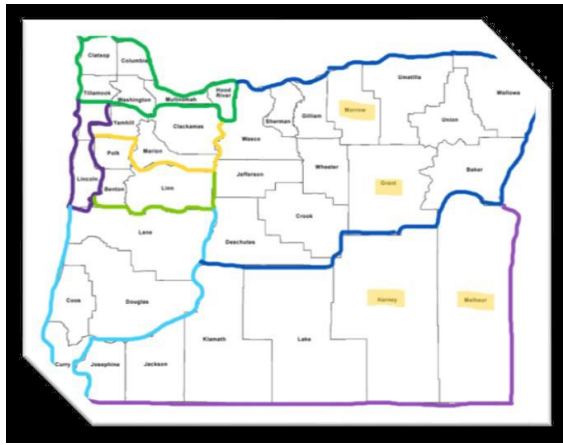

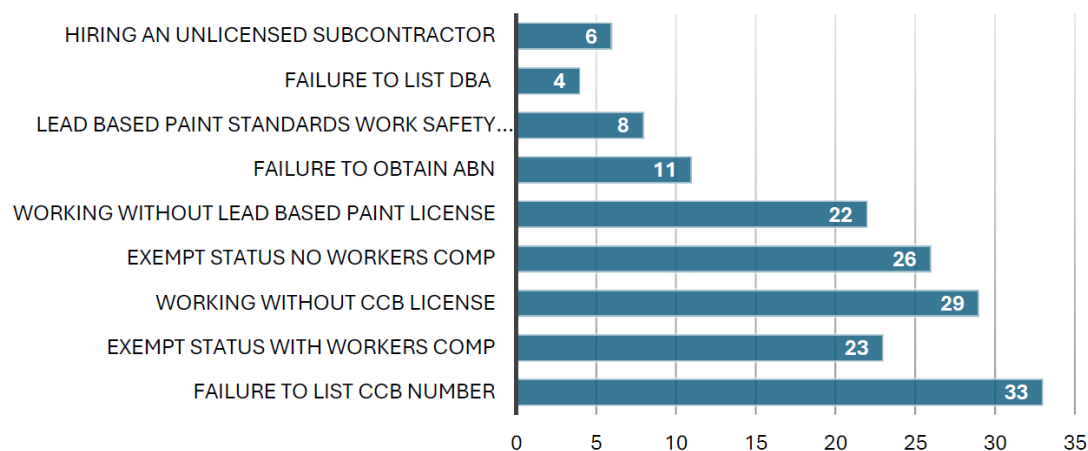

Field Investigations project work 2025:

- Social Media E-Warnings- In production phase 1, email warnings are being delivered to contractors who are reported through the TIPS line where an E-Warning applies. CCB received legal guidance about where we may start to approach social media advertising, we will continue to develop this item. About 25% or more of TIPS line complaints per month are instances of unlicensed contractors announcing their business and being hired via direct message by a consumer.
- Verizon Connect- This software was previously called Field Force, this upgraded system may allow us to dispatch an investigator who is closest to the report of illegal activity. This capability could enhance accuracy and response time. We plan to expand use of this product and test capabilities throughout 2025

Oregon CCB Investigators Visit Over 400 Jobsites In Search for Unlicensed Contractors

Salem – The Oregon Construction Contractors Board is investigating 68 potential violations after investigators visited 429 job sites looking for unlicensed contractors. This effort, which took place between October 13-24, was a part of a joint effort taking place over many states, coordinated by NASCLA (National Association of State Contractor Licensing Agencies). State licensing agencies associated with NASCLA all conducted their own efforts during this time.

During the event, CCB Field Investigators from around the state acted independently and in teams to discover unlicensed contractor activity. Efforts like this occur multiple times a year in different regions to show strong presence in the field and act as a deterrent for illegal construction activities, like working without a CCB license.

The findings:

- 25 percent of the proposed violations were in connection with advertising, bidding, or working without a contractor's license.
- The majority of remaining proposed violations included:
 - Lead-based paint violations
 - Working with employees on the jobsite while in exempt status. In some of these cases, the contractor may not have the required workers' compensation policy.
- Other violations span a range including no workers' compensation insurance and no Assumed Business Name associated with the license (ABN).

A typical first-offense penalty for working without a license is \$1,000 with subsequent violations resulting in fines of up to \$5,000.

“During sweeps, we focus on a designated region and the entire team combs cities looking for anyone breaking construction law. Unlicensed contractors can undercut the bidding process, which could have negative repercussions for homeowners and licensed contractors,” said CCB Enforcement Manager Vena Swanson. “Unlicensed contractors are notorious for using methods that don't meet industry standard, using sub-par building materials, and leaving homeowners at risk to pay workers compensation claims that occur on their property. Coordinated sweeps deter this illegal activity, while giving us the opportunity to find it and cite it.”

Who Needs a CCB License?

Anyone who repairs or remodels, as well as those who build new homes or businesses, must be licensed with the CCB. Contractors working on homes built before 1978 need special licensing and training to handle lead-based paint.

CCB's Message: Check the License

CCB encourages all homeowners to check their contractor's license before starting a home improvement project. Licensed contractors have a bond and insurance that offer some financial protections to the public. Also, homeowners may be able to get help from the CCB to resolve construction-related disputes if they use properly licensed contractors.
