- New Application records for November/December 2021 (avg 329/mo.) are approximately the same as recorded in November/December 2020 (avg 335/mo.). January 2022 new applications came in at 411 compared to January 2021 at 378 new applications, showing a slight uptick.
- Project update for email reminders for renewals. Implemented eReminders for contractors due
  to renew CCB license. Contractors will receive two email reminders and then a post card
  reminder in the regular USPS mail. Once the contractor renews their license, they will stop
  receiving email/post card reminders. Good response/results so far.
- Agency and statewide re-opening to the public was postponed. Licensing section front counter physical reconfiguration has been completed in preparation for new re-opening date TBA.

Normally that would be fine but when it's such an important test and you are showing all kinds of ID it makes the whole thing very questionable especially with all the scams and identity theft.

PSI testing VERY unprofessional and unorganized.

There was a disconnect between the licensing department and enforcement department. Enforcement correctly provided information to licensing that a fine had been paid in full, but licensing either did not see that information or ignored that information. The result is that our license showed as expired on the website for 32 hours. As a small business, we are already challenged with getting work during the winter and keeping employees busy. Our customers are savvy and DO look up the license status. The stress that those 32 hours caused is immeasurable. I don't know what's going on at the CCB, but this isn't the first

time I had a serious issue where an error caused me stress. This isn't just my livelihood, it's my employees as well. You need better protocols and you damn well shouldn't mark a license as inactive before checking off all the boxes.

Classes were totally out of date and essentially worthless.

This was one of the most challenging experiences I have had with a state agency. Having a license in the state can be a difference between working and not, and I didn't sense that anyone I spoke with or coordinated with cared whether or not I was working. I am sure you are short-staffed, and that's unfortunate. It causes challenges across the board for many. But it's not a reason to be courteous and responsive. There were times through out the process that I never received an email or call back well after the 2 weeks that was quoted, and so I continued to follow up. I am disappointed at the lack of empathy and expedience in the department to process the paperwork so my license could be reinstated.

I renewed on telephone after some questions were answered. Very pleased.

After renewing, I called into CCB directly and the phone staff was incredibly helpful. The guys name was Kevin and was super helpful and made it so easy to understand. The call went into after business hours and I'm so happy that he didn't rush me and continue to help me.

2021 Accomplishments and 2022 plans and goals for the Enforcement Division.

### **2021 Accomplishments and Updates**

- Filling Staff Vacancies: Enforcement Manager position has been filled, southern area Field Investigator/Mediator position is currently in training, newly promoted Dispute Resolution Analyst.
- Dispute Resolutions "Paperless" correspondence program was completed. We now have the ability to store and add documents as necessary in an automated environment. DRS was able to clear the system of outdated letters and notices from about 200 to about 30.
- Collections now has a paperless system for payment and reconciliation
- Collections stores everything electronically vs. on paper and this allows a more complete and streamlined process for reconciling, the system has a nightly back up process.

### **2022 Goals and Plans**

- Reinstate field sweeps statewide after the end of 1<sup>st</sup> quarter dependent upon COVID limitations.
- Work towards achieving an online DRS Complaint Process using 2-way electronic communication, our goal is to move closer to communication via email vs. sending letters USPS.
- Work closely with the Building Codes Division as a partner in creating a more current training program. We are also looking forward to a combined sweeps plan across the state.
- Update the new hire training process, our plan is to also appoint a LW in the field to implement ongoing coaching and training.

# Construction Contractors Board Dispute Resolution Services 2nd Quarter - 2021-2023 Biennium October 1, 2021 - December 31, 2021

Dispute Resolution Services provides a process designed to resolve construction disputes. It is available to persons or businesses alleging that contractors have breached a contract, performed improper work, or failed to pay for work performed or materials supplied. This service involves a mediation service to try to keep disputes out of the court system. If the dispute must be resolved by a court and the consumer who filed the complaint receives a court judgment but the contractor fails to pay the judgment, then the consumer has access to the contractor's bond for payment. Owners of construction companies are prevented from starting new construction businesses until all amounts awarded in the judgments are paid in full. When both parties participate in the mediation process, over 60-70% of those mediations result in a settlement agreement.

# Construction Contractors Board Compliance Section 2nd Quarter - 2021-2023 Biennium October 1, 2021 - December 31, 2021

The Compliance section is charged with evaluating evidence to substantiate violations of ORS 701 and OAR 812. Violation tips and complaints come from the Field Investigation Section (FIS), Dispute Resolution Services (DRS), on-line tips, phone tips as well as from local jurisdictions. The Compliance staff verifies a violation and determines whether an administrative warning or civil penalty is warranted. When warranted Compliance staff has the ability to enter into settlement agreements on behalf of the agency which is usually for a first time offenses. Respondents have a choice of entering into a settlement agreement which is conditional or opting to have an administrative hearing where the Compliance staff would represent the agency as a lay representative.

### Construction Contractors Board Field Investigation Section Quarterly Report for the 2021-2023 Biennium

Knowing that unlicensed and illegal construction activity is bad for consumers and legitimate contractors, the CCB established the Field Investigation Section in 2007, to provide statewide coverage and immediate response to complaints of unlawful activity in the construction industry. The staff includes 10 Investigators, each assigned to their own district in the state, where they are positioned to respond to complaints of illegal construction activity and conduct random checks of local construction sites. Sweeps are executed to find those involved in unlawful construction activity. The Field Investigation Section also participates in joint investigations with other state, county, and city agencies, some of which lead to the filing of injunctions or criminal charges.
