AGENCY REPORTS:

Chris Huntington, Agency Administrator updated on the 2023-25 Fiscal Summary. Reviewed the Rates of renewals from 2023 to 2024 and the overview of the revenue stream of new apps and renewals per month in 2024.

Updated on the License System replacement project, CCB continues to prepare for the procurement and implementation of a License and Enforcement System Modernization. The scope of the Licensing and Enforcement System Modernization is to replace all disjointed systems currently being used and provide one system where staff can see the entire history of a license including documents uploaded related to a license.

Reviewed the Agency Budget for 2025-2027

Dana Zeimantz, Licensing Manager reported

Project Update:

Licensing staff continue to participate in reviewing decision briefs, software requirements and developing use cases for the upcoming system replacement. This now includes data clean up in preparation for data migration to new software.

Began coordinating with Dispute Resolution unit for bond validation project

Current Quarter Highlights:

Top 3 reasons for customers calling Licensing are: Informational, Renewal and New Application status.

For applications received in January, that were also issued in January, the processing time was 8 days.

Agency compliance officers and manager participated in the annual Lay Rep training presented by Department of Justice.

The manager and lead worker participated in imaging software training.

Completed 19 quarterly performance feedback meetings with Licensing staff to review last year's performance and set new goals for the next quarter.

Noel Magee, IT Manager reported

There remain two primary focus areas for IT. The first and most immediate is the move to the State Data Center (SDC). The second area is the new system replacement activities. During this interval most retention and cleanup efforts have slowed in favor of SDC move activities and getting the new system replacement project through the next requirements, Stage Gate 2 (SG2) so that the RFP can go out. SG2 will likely be signed off by the date of this meeting.

Move to SDC:

1) A great deal of work to be done to get the "landing zone" at the SDC prepared so that it will accommodate CCB needs.

2) Primary control server being built and merging existing control (Active Directory) values over.

3) Networks have some very specific needs for CCB that we are working through. These also may be completed by the date of this meeting.

4) In Feb or early March, we should be moving or have moved development servers into the SDC area.

This Licensing System Replacement:

1) documenting current business processes so they can be more easily configured in whichever new software is eventually chosen is a heavy lift. This activity will pay back with more time and effort savings as the project moves forward.

2) Software development to implement the retention specifications during this period although it will take some months to complete. On hold waiting for resource.

3) Requirements are being reviewed again by each section and IT. This will further refine and clarify what we want to achieve.

4) Documentation under review for SG2 approved by procurement, security still pending.

We're reporting good numbers on the Security metrics, and they are back down where we prefer them to be.

Update

• **Upcoming Home Improvement Month** – This March will be the Education section's first Home Improvement Month, to be advertised in a press release and through the homeowner newsletter (which currently has a circulation of approximately 23,500). The newsletter is currently written and will be released toward the end of February. During home improvement month, CCB will offer three educational homeowner/consumer webinars.

- **Door-to-Door Sales: What to Do When the Home Improvement Comes to You - March 4**
This consumer protection webinar addresses the issue of door-to-door sales. Many construction scams start with this sales technique. The webinar will ask the question, how can you tell when it's a scam and when it's legit? The presentation will be discussed how consumers can protect themselves from scams and how to use CCB resources to look up contractors.
- **Fire Hardening Webinar - March 18**
This webinar will feature a presentation from Building Codes Division about how consumers can harden their homes against fires. At the end, CCB will present on best practices for hiring a contractor to do the work.
- **Choosing a Real Estate Agent, their Duties to You, and What to Do If Things Go Wrong - March 27**
This webinar will feature a presentation from Oregon's Real Estate Agency (REA). Speakers will provide consumers who are buying and selling a home with tips for choosing an agent and will discuss what to do when things go wrong. At the end, CCB will present on working with contractors to repair a home during the buying and selling process.

Vena Swanson, Enforcement Manager

Field Operations Update:

Planning phase for 7 sweeps April- October

Planning phase for 5 sweeps (Joint with ICN) May- September

Field Investigations project work 2025:

- **Remote Investigations-** This has moved from pilot to production. 5 cases have been investigated so far and 3 have been concluded successfully. We are relying on statements, documentation, and the probability of testimony vs. onsite discovery.
- **Social Media E-Warnings-** In production phase 1, email warnings are being delivered to contractors who are reported through the TIPS line where an E-Warning applies. CCB received legal guidance about where we may start to approach social media advertising, we will continue to develop this item. About 25% or more of TIPS line complaints per month are instances of unlicensed contractors announcing their business and being hired via direct message by a consumer.
- **Verizon Connect-** This software was previously called Field Force, this upgraded system may allow us to dispatch an investigator who is closest to the report of illegal activity. This capability could enhance accuracy and response time. We plan to expand use of this product and test capabilities throughout 2025.

Staff: Southern FI position is being filled, this position promoted to Mediator toward the end of 2024, we are happy to announce Joel Loudermilk as the South FI/M starting February 24th.

Compliance Update:

The Accounts Receivable function was trained successfully, this position was identified priority status and tasked with succession training in the CCB's strategic plan.

Compliance Section project work 2025:

- License Replacement System: Continuing use case documentation in this section as others in the division are now complete including Field Investigations and DRS.
- Remote online notary services (RON) required by DOJ for specific items: we are working through IT and procurement to meet this requirement and will start training compliance staff when we are granted access.
- License Conditioning SB228- Progressing; internal process and proposed language is awaiting legal approval.

Staff: The Office Specialist position has been open since the previous employee was promoted within the agency, we are happy to add Christina Kenoyer to the team on February 18th.

Dispute Resolution

Dispute Analysts and Mediation project work 2025

- Public facing complaints/CCB website- The mediation lead is assisting in creating a public facing records matrix that improves the types of complaints listed on the CCB website. We will be refining the criteria and putting these internal business rules in place by the end of 2025.
- Breach of settlement agreements SB228- Right now we are working to further define and develop the internal process and proposed language where enforcement penalties may apply to Breach of Settlement Agreements.
- Settlement agreement language revisions- This work is ongoing. (working with DOJ)
- Scheduled phone mediations- Implemented. Data collection and analysis is in progress and will be part of an ongoing review for success.
- Desk manual and training framework- This body of work is 95% complete, this didn't exist previously.

Staff: We are expecting the analyst position to go out for recruitment in the next 30 days, this is an existing position.







(Jan 2021 - Current)




Revenue Stream of New Apps & Renewals Per Month in 2025












Payments Received in 2025 to Date





Project Status Report

As of May 31, 2025

Project High Level Status

CCB continues to prepare for the procurement and implementation of a License and Enforcement System Modernization. The scope of the Licensing and Enforcement System Modernization is to replace all disjointed systems currently being used and provide one system where staff can see the entire history of a license including documents uploaded related to a license. The system must be user friendly and provide licensees and other users the ability to serve themselves through online capabilities. CCB anticipates that the implementation of a modern system will bring multiple opportunities for business process reengineering.

The Department of Administrative Services, Enterprise Information Systems (EIS) requires agencies replacing major information systems to pass through a series of Stage Gates in order to ensure the success of such projects. In January, 2025, CCB received notification from DAS EIS that Stage Gate 2 has been approved.

Licensing staff is currently working through a backlog from the busy season cycle. This creates increased phone calls and paperwork. New applications are currently being issued in 4-5 weeks.

Licensing team met with the Landscapers Board to collaborate and share bond increase project details.

Licensing teams completed use cases for bonds and general liability insurance.

Project Update:

Ongoing Activities

There remain two primary focus areas for IT. The first and most immediate is the move to the State Data Center (SDC). This process is on track and on time. The second area is the new system replacement activities. During this interval most retention and cleanup efforts have slowed in favor of SDC move activities and getting the new system replacement project through the next requirements so that the RFP can go out. This process is also on track although waiting for external events at this particular point.

Move to SDC:

- 1) A great deal of work to be done to get the "landing zone" at the SDC prepared so that it will accommodate CCB needs. **Completed**
- 2) Primary control server being built and merging existing control (Active Directory) values over. **Completed**
- 3) Networks have some very specific needs for CCB that we are working through. These also may be complete by the date of this meeting. **Completed**
- 4) Production servers moving to SDC (1 moved, more to come). **In Progress**

This Licensing System Replacement:

- 1) documenting current business processes so they can be more easily configured in whichever new software is eventually chosen is a heavy lift. This activity will pay back with more time and effort savings as the project moves forward. **In Progress**
- 2) Software development to implement the retention specifications during this period although it will take some months to complete. **In Progress**
- 3) Documentation under review for SG2 approved by procurement, security still pending. **In Progress**

We're reporting good numbers on the Security metrics.

➤ **Security reported status - Reported monthly by EIS/Enterprise Security Office (ESO)**

- ◆ The state numbers may be confusing. This percentage is arrived at by comparing the number of vulnerabilities found to the number of systems that have a vulnerability. So a single system with 2 critical vulnerabilities would rate 200%. Thus 155% means that, on average each vulnerable system has 1.55 vulnerabilities.
- ◆ During the current period our security numbers came back in line with our ordinary range.

Background & Objectives

- The Oregon Contractors Construction Board (CCB) regulates the construction contractor industry and promotes a competitive business environment through education, contractor licensing, dispute resolution, and law enforcement.
- Since 2001, the CCB has conducted an annual Statewide Homeowner Survey with Oregon residents.
- As in past years, the goal of the 2025 Wave 9 survey is to understand homeowners' awareness levels of and attitudes toward the agency and its services. In addition, the questionnaire was constructed to measure:
 - The percentage of Oregon homeowners who understand and rate the value of hiring a licensed contractor; and,
 - The percentage of Oregon homeowners who are aware of their rights and responsibilities, and the services offered by the CCB.
- Through this research, the CCB would also like to identify areas in which homeowners need to be educated, and how to best reach them.
- **Beginning with the Wave 7 (2021) data, we changed the data collection method from a telephone sample to an online panel participant list. All data was collected online for Wave 8 (2023) and Wave 9 (2025).**

Methodology & Sampling

- Since 2014, the CCB has contracted with the Logit Group (formally Issues & Answers) to conduct their annual Statewide Homeowner Survey. Fielding for the 2025 survey took place from March 27 5, 2025 to April 10, 2025.
 - In total, 806 Oregon homeowners were interviewed (405 males / 400 females).
 - All interviews were conducted online and lasted approximately 5 minutes each.
- To ensure a geographically representative sample of Oregon homeowners, regional quotas were implemented based on census estimates. Below is a summary of completes per region.

Analytical Summary

- For comparison purposes, respondents were segmented into various sub-groups based on demographics, behaviors and perceptions.
- Significance testing (t and z tests) at the 95% confidence level was conducted to detect significant differences among respondent segments. When applicable, these findings will be noted.
- Participants were asked up to two open-ended questions to aid in understanding the "whys" behind the numbers. Responses to these questions have been coded (when applicable) and tabulated for inclusion in this report.
- In some instances, percentages may add to more or less than 100% due to rounding and multiple response answer choices.
- Throughout the report, statistical differences between Waves 8 and 9 have been noted with a “▲▼” arrow/symbol.
 - New in Wave 9: To consolidate historical results, waves were combined into two-year averages to maintain data review while creating a cleaner data presentation. At times, Waves 9 and Waves 8 may be called out individually in the charting for statistical designations.
 - Waves 1 & 2, average sample 500 homeowners
 - Waves 3 & 4, average sample 500 homeowners
 - Waves 5 & 6, average sample 500.5 homeowners
 - Waves 7 & 8, average sample 814 homeowners



Key Insights

Key Insights

The Wave 9 results are both consistent with portions of Wave 8, as well as differ in some areas. Since the data collection is now uniformed between the most recent waves (both online data collections), the differences highlighted are worth exploring deeper with any operational changes that may have occurred and if they align with the organization's communications and outreach.

In addition, trends we're continuing to see in this space that may be continuing to impact results include:

- The COVID-19 pandemic that altered people's lives, construction projects, homeownership rates, and interest in home improvement projects.
- Consistent with Waves 7 and 8, Wave 9's respondent profile includes mostly older (45+), though Waves 8 & 9 have a higher percentage of college educated homeowners. Gender remains balanced.
- We witnessed another significant uptick in the building of new homes, than any previous wave. (Remodeling and home improvement has remained consistent, purchasing existing homes down slightly but not significantly.)

- Overall awareness of CCB is remains high year-to-year. Currently, awareness is **79%**, a 1-point increase from Wave 8. Word of mouth continues to be a powerful source of information (**49%**); though we're seeing a resurgence of awareness from combines Television (**86%**), Radio (**61%**), or Home Shows (**24%**).
 - Newspaper article references are also trending up, from **33%** in Wave 7, to **37%** in Wave 8, to 45% in Wave 9.
 - When looking for a contractor, mentions of both Internet lists (**40%**) and the contractor association website (**54%**) remain comparable between Waves 8 and 9.

Word-of-mouth has always been a high discovery route, additional research could be used to investigate the role of social media and contractor content if further dissection is needed.

- Consistent with Wave 8, **96%** of homeowners who are aware of the CCB know the agency licenses contractors. This data point remains stable and high.

Key Insights, cont'd.

- Also maintaining from Wave 8, **74%** of homeowners who are aware of the CCB recall having contact with the Board during the past five years.
 - The incidence of contact is also comparable (and high) among those who have built a new home in the past five years (**94%**).
- In a reversed trend, the most often cited reason for contacting the CCB was for contractor verifications (**76%** vs 62% in Wave 8). Complaints are down from a Wave 8 high (72%) to **60%**.

Key Insights, cont'd.


- The vast majority (**90%**) of Oregon homeowners have constructed a new home or undertaken remodeling/home improvement projects within the past five years—Consistent with Wave 8 (**91%**) and a continued rise from Wave 7 (**64%**).
 - **Concerning Story:** **8%** of homeowners who built either did not, or were unsure, if they hired a professional for the build. This is twice the number from Wave 8 (**4%**).
 - **Good Story:** Fewer people are unaware that it's illegal to hire a contractor not licensed with CCB (down to **7%** from **12%**). And a new all-time high (**77%**) know it's illegal.



Detailed Findings: Awareness of and Contact with the CCB

Awareness of the CCB

- More than three-quarters (**79%**) of Oregon homeowners have heard or read about the CCB. This is consistent with Wave 8 (**78%**).
 - In Wave 8, Males & Females were equally aware of CCB (78%), in Wave 9 Males are significantly more likely to be aware (**85%**) compared to **72%**.
 - College graduates also have a significant higher awareness than non-college graduates (**87%** vs. **52%**)
 - In Wave 9, the Southern region has the most awareness at **84%**, followed by...
 - Central/East Coast (**80%**)
 - Portland (**78%**)
 - and Willamette Valley (**73%**)



- While awareness has been consistent across modern waves, traditional word of mouth from family, friends, or acquaintances is the most common way homeowners report becoming aware of the CCB (**49%**).

 - Television PSAs (38%)
 - Radio news stories (31%)
 - Home Shows (24%)



 - Those who did not use a licensed contractor (92% awareness)





Contact with the CCB

- A consistent **74%** of residents who are aware of the CCB have had contact with the agency during the past five years.
- In addition, residents who either (1) built a new home or did remodeling/home improvements or (b) hired a contractor - maintain high levels of communication with CCB (**82%** & **85%**).
- Contact with CCB to verify licenses is high, at a record **76%**, up significantly from Wave 8. While communication to report problems (**60%**) or from a tradesman (**38%**) are both down significantly.






Detailed Findings: Resident Behavior

New Home Construction / Home Improvement Projects

- More Oregon homeowners have built new homes than any past wave (**40%**), a new record high.
- Remodeling has remained stable over the years, with a slight uptick in recent waves.
- Purchasing an existing home remains consistent across Waves 9, 8, & 7.
- In Wave 9, men were more likely to report building a new home or purchasing an existing home (**47%** and **42%**), while women were more likely to mention remodels (**58%**).

New Home Construction or Home Improvement Projects in Past 5 Years





Contractors' Licenses with the CCB

- Wave 9 has the return of more typical experiences with **2%** of Oregon homeowners report knowingly hired a construction contractor who is not licensed with CCB. This is up from 0% (a record) in Wave 8.
- A new all-time low, only **9%** of homeowners are unaware of their contractor's licensure status.
- Homeowners who are aware of the CCB are consistently more likely to have hired a licensed contractor compared to those who are unaware (**96%** Wave 9, **94%** Wave 8)
- While more people knowingly hired a contractor not licensed with CCB (11 people), most common reasons ranged from





Verification of Contractor's License

- In a continued trend, MORE homeowners **(92%)** verified their contractor's license with the CCB than those who did not check for credentials **(7%)**. A new record high. *(Up 1% from Wave 8)*

Reasons for Not Verifying License


- 12 homeowners (34%) mention being unaware of needing to verify a contractor's license. While small sample sizes, this is a somewhat significant departure from past trends depending on **trust** and contractors **volunteering** their credentials.
- Reputation** of a contractor is at an all time high for reasons not to verify a license (14%)
- Personal connections** to contractors has reduced drastically, with an all time low of 3% for reasons why verification was not conducted.



- A referral from friends, relatives, colleagues, etc. is still the most commonly cited way to look for a contractor for home construction or repairs.
- Both Newspapers (**41%**) and Radio/Television (**35%**) mentions are up considerably compared to past waves
- Contractor association website (**54%**) have remained steady the last few waves.
- Home shows (**25%**) are also making a notable uptick in referenced mentions.


Q14a. If you were looking for a contractor for home construction, remodeling, or repairs where would you go first to select a contractor?





- More than three-quarters (**77%**) of Oregon homeowners are aware that it is illegal to hire contractors for construction, remodeling, or repair work who have not been licensed by the CCB, a significant increase from Wave 8 (72%).
 - And **fewer people are unaware**, in a significant decrease, only **7%** of homeowners from Wave 9 do not know.
- A new high, **88%** of homeowners aware of CCB know this is an illegal practice, statistically stronger than both those who don't know about the the organization (**36%**) or are unsure if they know (**25%**).

Amount of Licensing Regulation

- Compared to Wave 8's high of **29%**, Oregon homeowners have come back down significantly with believing there is too much regulation to a present **23%**.
- Nearly three-quarters (72%) believe the regulation balance is 'about right', significantly higher than Wave 8's **65%**.
- Only **3%** say current regulation is insufficient.

Advertising Your Services? Include Your CCB Number!

All contractors must include their CCB license number on advertisements. This includes business cards, site signs, and more. The number should include “CCB” and then your license number (for example, CCB #123456). You can also include the words “Licensed and bonded.” License numbers are required on:

- Business cards
- Written bids
- Building-related contracts
- Advertising, including websites, telephone book, newspaper, radio and television ads.
- Business letterhead
- Business signs at construction sites
- Written inspection reports
- Business vehicles with signage

Are CCB numbers required on promotional items?

No. CCB numbers are encouraged but are not required on promotional items where it is not practical to include them. This includes pens, pencils, bug deflectors, refrigerator magnets, etc. Numbers are also not required on clothing or uniforms for sports teams sponsored by construction businesses.

What happens if I don't include my CCB number on an advertisement?

There's more than one reason to include your CCB number on an advertisement.

- Potential customers who see your license number on your business cards, bids, etc. can quickly confirm your license status on our website or by calling 503-378-4621. If they're unable to find you in the CCB database because they don't know your license number, you could lose out on business.
- Putting your CCB number on your advertisement reminds consumers that the CCB number is a requirement. Keeping this information on their mind when they're hiring a contractor benefits you, because your business is licensed. This distinguishes your business from unlicensed contractors.
- Failure to include your CCB number on an advertisement is a violation of OAR 812-003-0120. This can incur a fine of up to \$400.

Reminder About Contractor New Application Fees

In March 2024, the Board approved a fee increase on all CCB license renewals and new applications. The fee increase went into effect for renewals in July of 2024. To support new contractor businesses, the Board elected to delay the fee increase for new applications until July 2025. The contractor application fee increase will take effect on July 1, 2025. Contractors that submit new applications after June 30, 2025, will pay \$400.

More Information About the Increase

The Board adopted this fee increase in support of preserving CCB enforcement, licensing, and other services. Message from the Oregon Department of Agriculture:

PESTICIDE USE REMINDERS ON ROOFS AND OTHER CONSTRUCTION SITES

Roofs, areas around structures, and other construction sites are common areas where pests can be a problem. For example, moss is widespread on roofs and other structures (e.g. driveways) in the damp areas of the Pacific Northwest. It is common for people to use products that prevent or kill moss, and to treat wood roofs to prevent wood-destroying pests. Products to kill weeds may sometimes be used in a site prep.

Many people do not know that these types of products ***are classified as pesticides*** at the state and federal levels and ***applying them commercially requires a pesticide applicator's license***. Additionally, each product must be registered before being applied commercially to control moss, weeds, or other pests on a customer's property. The Oregon Department of Agriculture (ODA) Pesticides Program regulates the sale, use, and distribution of pesticides in Oregon.

Individuals and businesses must be licensed by ODA before performing certain pesticide-related activities. In general, a Commercial Pesticide Applicator license is required to apply a pesticide to a customer's property. Additionally, their employer (business) must have a Commercial Pesticide Operator license. Commercial pesticide licenses have categories, which limit or specify the type of pesticides that can be used and/or locations where pesticides can be applied. More information on licensing can be found on our website at <https://oda.direct/PesticideLicensing>

Always follow the pesticide label. Pesticide product labels provide critical information about how to safely and legally handle and use pesticide products. This includes information, such as mixing (dilution) rates, how to properly apply, requirements to prevent off-target movement and protect the environment, emergency first aid instructions, and how to dispose of the empty container. Pesticide labels are lawfully enforceable, and carry the statement, "It

is a violation of Federal law to use this product in a manner inconsistent with its labeling.” In other words, **the label is the law**. For more information about pesticides and to search for registered pesticide products, go to <https://oda.direct/SearchRegisteredPesticides>

Construction Scams: What to Know

Spring brings home improvement to front of mind for many homeowners. Unfortunately, this time of year also brings out scam artists offering too-good-to-be-true services. Knowing how to identify the warning signs of a scam can help you protect yourself from becoming a victim.

Red Flags It's a Scam

Scam artists use many of the same tricks to convince homeowners to give them money. These patterns emerge again and again in scams ranging from pavement scams to disaster scams. Below are some of the red flags to watch for.


- You feel pressured to act now. A good contractor will always give you space and time to make the right decision for your project. Scam artists might make a "limited time only" offer, forcing you to rush the decision without considering your options or vetting other contractors.
- The offer is too good to be true. Be wary of anyone who promises what other contractors say is impossible. If the offer sounds too good to be true, it probably is.
- The price is dramatically lower than other prices you've been quoted. If a contractor is offering to do a job for a fraction of the cost that other contractors say they must charge, ask yourself: Why? How?
- Out-of-state plates on the contractor's vehicle. Traveling scam artists evade law enforcement by going from place to place, finding

victims, and leaving before they can get caught. Remember, out-of-state contractors can come to Oregon to do work, but they must have an Oregon contractor's license.

- No CCB number or reluctant to give you the CCB number. Don't hire anyone who doesn't have an active license. If the contractor says they have a CCB number but don't want to give it to you, this is a red flag. A CCB contractor should be willing and able to give you their number so you can check it on the CCB's website.
- Workers demand all or most of the money up front. It's normal for contractors to charge some money up front. The downpayment is used to buy materials and get the job started. However, if the contractor wants to charge all of the money up front, this could be a sign of a scam.
- Scammer comes to you and offers a free inspection. Scam artists often go door to door and offer "free inspections." Once they gain access to your house, they find damage you didn't know you had and tell you that it's urgent.

Who's At Risk?

Anyone can be the victim of a scam, but the most vulnerable people in our communities tend to be the elderly, new homeowners, and recent disaster victims. Stay educated and informed. Watch for the warning signs of a scam any time you're considering taking on a home improvement.



How to Protect Yourself and Your Community

Check the CCB license: Use the CCB's online search feature to look up your contractor's CCB license before hiring them to do the work. Use the search feature to ensure that the contractor has an active license, and look up to 10 years of history on the contractor's license.

Follow best practices when hiring contractors: Vet at least three contractors before hiring one for a major home improvement. Ask many questions during your meetings with contractors. Check references.

Report unlicensed contractors to the CCB: Unlicensed contractors undercut legitimate licensed contractors, making it harder for licensed contractors to operate within the law. Unlicensed contractors also put consumers at risk because they're operating outside the boundaries of the law. People who hire unlicensed contractors don't have access to the same consumer protections as people who hire licensed contractors. By reporting unlicensed contractor activity, you can help protect neighbors and people in your community who might become victims of unlicensed contractor scams. You can report unlicensed contractor activity – anonymously or not – through the CCB's website: https://search.ccb.state.or.us/online_complaint_enf/

Get a contract: A contract is required for jobs over \$2,000, but we recommend getting a contract even when the job will cost less than \$2,000. Getting a contract helps keep you and the contractor on the same page.

Talk to friends, neighbors, and family members about scam awareness: Scams affect everyone. Talking to people you know about scams can help increase scam awareness. It's especially important to talk to people who live alone and the elderly, because they are at higher risk of becoming victims. If someone you know is thinking about taking on a home improvement project, offer to be a sounding board. Often, people can make better home improvement decisions when they're able to talk through their concerns and questions with someone else.

Common Scams

Many scams follow patterns, which can make them easier to identify. Below are some common scenarios that homeowners experience when they're experiencing these scams.

Paving scams. The unlicensed contractor comes to your door and offers to repave your driveway for an unusually low price. They may explain they just finished a job down the street and have leftover material. They'd like to offload the material before they move on. They may be driving nice trucks and have out-of-state license plates. You agree on a price, and they get started right away. Soon, they try to raise their price - maybe dramatically more than the original amount. They're intimidating. They cash the checks as soon as they leave your property. The work they did, if they finished at all, washes away with the next rain.

Disaster scams. Following a disaster, unlicensed contractors start leaving flyers and business cards on doors of disaster victims. They're available starting right away. They have no contractor's license. They charge a high up-front amount, or maybe the whole cost of the job. They're offering to do what other contractors have said can't be done, or what other contractors can't get to for months.

Roofing scams. The scam artist comes to your door and tells you that something looks wrong with your roof. They may tell you that they installed your roof years ago and they'd like to check on the work. Either way, they offer you a free inspection. The free inspection reveals "problems" that are hard for you to spot. The scam artist offers to repair your roof for a high price. They say the problem is urgent and make you feel afraid to say no.

Know Your Resources

Knowing your resources can help you through your home improvement process.



Field Investigations project work 2025:

- Remote Investigations- Historically, CCB responded to mostly active jobsites. We have found that we can be successful using the criteria attached. The burden of proof in a hearing is CCB's responsibility.
- Social Media E-Warnings- In production phase 1, email warnings are being delivered to contractors who are reported through the TIPS line where an E-Warning applies. CCB received legal guidance about where we may start to approach social media advertising, we will continue to develop this item. About 25% or more of TIPS line complaints per month are instances of unlicensed contractors announcing their business and being hired via direct message by a consumer.
- Verizon Connect- This software was previously called Field Force, this upgraded system may allow us to dispatch an investigator who is closest to the report of illegal activity. This capability could enhance accuracy and response time. We plan to expand use of this product and test capabilities throughout 2025.

Dispute Analysts and Mediation project work 2025

- Public facing complaints/CCB website- The mediation lead is assisting in creating a public facing records matrix that improves the types of complaints listed on the

CCB website. We will be refining the criteria and putting these internal business rules in place by the end of 2025.

- Breach of settlement agreements SB228- Right now we are working to further define and develop the internal process and proposed language where enforcement penalties may apply to Breach of Settlement Agreements.
- Settlement agreement language revisions- This work is ongoing. (working with DOJ)
- Scheduled phone mediations- Implemented. Data collection and analysis is in progress and will be part of an ongoing review for success.
- Desk manual and training framework- This body of work is 95% complete, this didn't exist previously.

Remote Investigation Criteria

Reports of:

- Contractor is licensed; allegations are that they are working out of scope or the endorsement of their license. Example: RGC is completing a large commercial job or a Residential Limited Contractor is working outside of their endorsement.
- Contractor is completing work under their license but is not properly credentialed for LBP or trades work. (Trades work may be referred to BCD).
- The contractor did not have a license when the work was done or is/was previously licensed but suspended when the work was done.
- There is no statute of limitations for enforcement actions when the work occurred. Anything within the last 2 years timeframe will be sent to the FI in the area for additional fact finding or investigation.

Criteria:

- Information in any one of these areas can be enough of an identifier to send it forward to field teams: name, phone number, address, license plate, business card.

AND

- Information showing that work was done such as proof of payment, contract, photos, camera footage, written owner statements for testimony, bid or invoice.
- Advertising information the homeowner might have seen or used in hiring a contractor.

Other criteria

- Police reports regarding a contractor.
- All reports verbal/written from other agencies, building officials and municipalities.
