Subject: Consider final action on proposed fee increase

## Action Requested

Approve proposed CCB license fee increase rule for final adoption.

## **Background**

CCB is a fee-for-service agency – service delivery is directly tied to fees paid by contractors. Unlike many other agencies, CCB's capability to ensure continuity of services is directly tied to economic activity in the construction industry. For CCB, this economic activity is reflected in contractor license fees. The agency closely monitors construction activity generally for any possible impact it may have on agency revenue and makes necessary adjustments in order to match available resources to service delivery.

Beginning in July of 2023 the board has been engaged in review and discussion related to the need for either revenue adjustments or service cuts in order to balance the agency's budget. Revenue generated by current fee rates will not support even existing service levels moving forward. Revenue and expenditure projections for the current biennium suggest an approximate \$2.0 million deficit between revenue and expenditures. The primary driver is labor cost inflation since the fee was last increased in 2010. Over that period, labor costs are up nearly 55%.

To be clear, the cost increase is not the result of significant growth in staffing. Rather, agency staffing has been relatively static since agency staffing was reduced in 2013 (61 in 2013, 59 as of March 2024). Over a period of years, the agency has taken steps to hold down costs by maintaining existing staffing levels, notwithstanding growth in the industry.

However, labor cost increases make this path unsustainable. The agency needs to make an adjustment in order to:

- Promote financial stability for the organization;
- Support continuity of services for our customers; and
- Ensure the viability of modernization efforts, which promise to significantly improve agency efficiency and reduce long-term costs.

During prior meetings, the board has provided direction to prioritize increasing revenue through fee increases to support current service levels as opposed to making the steep cuts that would be needed to balance the agency budget without additional revenue.

During the December meeting, the board approved for public rulemaking and comment a proposal that would increase the two-year contractor license fee by \$75 for a total of \$400. The fee increase would be implemented over a two-year period, beginning for renewals in July of 2024 and beginning for new applications in July of 2025.

The board's decision to move forward with a proposed fee increase was based on the board's determination that the proposal in necessary in order to maintain adequate service levels and support modernization needs.

## Factors Affecting the Proposed Fee Increases

As discussed during prior board meetings, there are numerous factors that weigh on the decision:

- Last fee adjustment: The agency's currently established fee was last adjusted in 2010, thirteen years ago. That adjustment was \$65. The prior interval between fee increases was just 6 years.
  - **NOTE:** During this interval the board also temporarily reduced fees from \$325 to \$250 during two biennia. This decision reduced reserves and also has some impact on the timing of this current set of proposed actions.
- **Personal services costs**: Costs of staffing have increased for the agency, as they have for almost all industries, including the construction industry. Since 2010 agency total labor costs are up almost 55%, notwithstanding reductions in total staffing.
- **Staffing-to-Contractor Ratio:** While agency staffing has remained static, the number of contractors has steadily increased since the end of the prior economic recession. In 2013, agency staffing was adjusted downward to 60 from 80+ at a time when there were approximately 35,000 contractors in the state. Since that time staffing has remained relatively static while the number of contractors has grown.
  - 2010: 1 staff member to 550 contractors
  - 2024: 1 staff member to 847 contractors
- **Critical Investments Needed:** Over the last several years the agency has taken steps to build reserves in support of a critically needed IT investment replacement of the agency's 30+-year-old license database. Action on fees will allow the agency to protect the reserves that have been set aside for this purpose. The agency estimates the 5-year cost of the replacement to be \$2.1 million based on written estimates from multiple vendors. Failure to take action to adjust revenue will put the project at risk and set the agency back, limiting our ability to best serve our customers and become a modern and efficient organization.

## **Public Comment Period**

Based on the approval the board granted at the December meeting, the agency filed a rulemaking and opened a public comment period in early January. The agency deliberately held a lengthy comment period, several weeks longer than what is required, in order to maximize opportunity for feedback. The consolidated comments are part of the packet for review.

In addition to the statutorily required notifications the agency also did the following:

- Sent out three separate notifications to our largest email list of approximately 88,000 recipients:
  - A Bulletin sent on January 5, 2024 Delivery success 94% -- Open rate 29%
  - Newsletter sent on January 12,2024 Delivery success 94% -- Open rate 22%
  - Final Reminder Sent March 1, 2024 Delivery success 94% -- Open rate 25%
- Set up a web page dedicated to providing information about the proposed increase with prominent links on the agency's front page.
- Held two public information webinars to provide information about the basis for the proposal. The agency also recorded and posted the webinar. It was linked in the final reminder. The presentation from the webinar is also attached with these materials.

Agency leadership has closely reviewed and considered all of the comments received and encourages the board to do so as well. In addition to comments on the fee proposal itself, there are many worthwhile suggestions about how the agency can perform our work in a fashion that will more clearly demonstrate the role and benefit that CCB plays in ensuring a level playing field for the construction industry in Oregon.

Regardless of final action approved by the board on the current proposal, agency leadership suggests that we convene some workgroups to discuss a range of topics included in the comments, including improvements to the education program and a long-term financial model that addresses some of the comments request for a planned schedule of possible increases based on pre-determined factors and exploration of a model that could feasibly reflect different types of entities without needlessly increasing workload and cost for the agency.

## **Proposed Action**

The agency believes that the current proposal can be justified and is the clearest most certain path to provide solid financial support for the agency and ensure the viability of the sorely needed license system replacement project.

## NEED FOR THE RULE(S)

OAR 812-003-0142 is amended to establish a fee increase to the CCB licensing fee from \$325 to \$400 for a two-year license effective July 1, 2024, for all renewal applications, and effective July 1, 2025, for all new licensees as authorized by the CCB Legislatively Approved Budget.

At the December 6, 2023 Construction Contractors Board meeting, Board members determined that a license fee increase was needed to adequately fund the CCB and maintain reserves for needed licensing system improvements. The last fee increase was effective July 1, 2010.

license. This fee increase is effective July 1, 2024, for all renewal or reissue applications, and is effective July 1, 2025 for all new licensees.

This is an increase of \$37.50 per year or \$75 for a two-year license period. The last fee increase was effective July 1, 2010.

1. No additional state agencies or units of local government are likely to be impacted by this rule. Members of the public who are engaged in construction contracting, or who make use of the services of construction contracting businesses, may be minimally impacted by this rule.

2. (a) As of end of November 2023 there are 49,769 total licensees licensed by the Construction Contractor's Board, all of which will eventually be subject to this rule and fee increase. Information about business size is not reported to the agency; however, it is likely that a significant portion of licensees would qualify as small businesses.

(b) No additional reporting, recordkeeping and administrative activities and costs anticipated.

(c) No additional cost of professional services, equipment supplies, labor and increased administration anticipated for compliance with the rule.

## DESCRIBE HOW SMALL BUSINESSES WERE INVOLVED IN THE DEVELOPMENT OF THESE RULE(S):

The agency works with its Board to develop administrative rules. Several of the current nine Board members are business owners. The Board requested its Administrator conduct outreach to small business owners prior to adoption of the fee increase by the Board. The Board requested that the comment period for the rule extend through the 2024 legislative session and include a rulemaking hearing in March 2024 to allow anyone who wants to comment on the proposed rule to do so.

## WAS AN ADMINISTRATIVE RULE ADVISORY COMMITTEE CONSULTED? NO IF NOT, WHY NOT?

The agency uses its Board which is made up of six contractors; one elected public official, and two public members who review and approve the agency's administrative rules. Some of the Board members are members of industry associations who discuss proposed rules with their associations and then report back to the Board on any information gleaned from such discussions. As noted above, the Administrator for the Board was also requested to conduct outreach to the construction community on this proposal and to report back to the Board on the information learned.

RULE SUMMARY: License Application Fees

CHANGES TO RULE:

812-003-0142 License Application Fees ¶

(1) Except as provided in section (6) of this rule ffective July 1, 2024, the application fee for all renewal or reissued licenses is \$400. For applications received on or before June 30, 2024, the application fee for all new, renewal, or reissued licenses is \$325.¶

(2) Except as provided in section (6) of this rule, for the period from July 1, 2019, through ffective July 1, 2025, the application fee for all new licenses is \$400. For applications received on or before June 30, 20215, the application fee for all new, renewal, or reissued licenses is \$2250.¶

(3) Except as provided in section (4) of this rule, application fees will not be refunded.¶

(4) If a licensee submits an application to renew a license and the agency cannot renew the license because the applicant has formed a new business entity, the agency may refund the renewal application fee, less a \$40 processing fee.¶

(5)(a) Any licensee in the United States armed forces need not pay a license renewal fee if such fee would be due during the licensee's active-<u>-</u>duty service.¶

(b) A licensee in the United States armed forces shall pay the next license renewal fee that will become due after the licensee is discharged from active-<u>-</u>duty service.¶

(c) The agency may request that the licensee provide documentation of active-<u>-</u>duty status and of discharge.¶

(d) Section (5) of this rule applies to licensees that are sole proprietors or partners in a general partnership.

(6) A new license issued pursuant to HB 4144 (2018) to a sole proprietorship that satisfies the requirements of HB 4144 and OAR 812-006-0162 does not require an initial application fee. This fee exemption expires on January 2, 2022.

Administrator Huntington,

Contractors and workers in Oregon support CCB's ongoing efforts to improve customer service and ensure a level playing field. We understand the agency must maintain adequate funding to provide services to both consumers and contractors. Efficient and timely processing of license applications, renewals, and contractor education is important for the success of our industry. We encourage the agency to make sure consumers are protected by making sure contractors are licensed and bonded. We ask that the agency endeavor to resolve consumer complains at the lowest level possible through mediation and dispute resolution, and when appropriate take steps to hold bad actors accountable.

Although no business or individual ever wants to pay more, we understand cost adjustments are necessary from time to time. We also understand CCB has not increased rates since 2011.

Going forward, we ask CCB to consider the timing of fee adjustments and work with industry to determine whether periodic increases would be a better path than larger increases on a less frequent rate. It is also important that CCB aggressively ensure the monies spent by contractors are used for the benefit of consumers and contractors, and to avoid using CCB funds to subsidize other government functions not related to construction.

We appreciate the opportunity to provide comment and the transparent communication from the agency. We support the agency's fee proposal.

Ricky Young, Business/Organization: RY Construction	Indeterminate	I have been a licensed general contractor in the state of Oregon for 25 plus years. Along with raising the fees I would love to see the CCB do an apprenticeship style program to be able to become a licensed general contractor. The 16-hour open book test is not a way to make sure that somebody is qualified to be a builder/general contractor. We allowed far to many people get licenses with no training whatsoever I have been back on many jobs to fix and repair shoddy work by incompetent contractors (illegal and legal) roofers, siders, sheetrockers and more. I will never say that I am the best at anything in this industry. I do try my best to give a customer a quality product and a good end result. If I wanted to be a plumber I have to go through a apprenticeship training course usually several years, if I want to be an electrician I have to go through a training course usually several years, HVAC is the same way. Every trade that isn't quote on quote a general contractor?builder takes several years of training to be able to become a journeyman or a top level in that trade. Why is it that the CCB thinks that a 16-hour open book test is enough to be able to be a general contractor? The only thing I can come up with is that it's revenue revenue revenue revenue! I don't mind paying but I'd like to see something done to actually make the construction industry better. We need to go to some type of an apprentice type structure where somebody vouchers for the needed training. Perhaps, that is a good thing, because I have never had a complaint against me to your office. So, here is my proposal. Rather than all contractors paying the same license fee, have a point system. For each complaint that a contractor license number receives, they would receive a point. Each point would have a dollar value which would be variable based on the severity of the complaint and the time and trouble it causes your office. Then, at license renewal time that contractor would pay an additional fee based on the number of points they have accumulated during the two years. The rest of us who have no interaction with your office, would be allowed to stay at the \$325.00 current fee. Since then, I have helped a number of my friends try to navigate the various obstacles and tests needed to get licensed as contractors. The reason I am emailing today is that I am utterly astonished at the time it is taking the CCB to process their requests for licenses. One of my friends has been waiting to hear back since he turned in all his paperwork in November. Another turned his paperwork in in the beginning of January. Neither of them have heard anything back. They call in to the CCB to try and inquire about the status and they receive terse answers that are not helpful. They check the website everyday to see if they have a license and still do not. Another one of my friends said it took the CCB 6 months to get him his license. This is a problem and I am glad you are trying to do something about it. The CCB really really needs to hire more people to handle license requests. I can't stress this enough. If this was a company I was trying to do business with, I would simply look for a different company to go with but we cannot. Contractors are stuck with the CCB and there are no other alternatives to licensure. The inaction of the CCB to remedy this situation is depriving many people of a way to make a living and probably forces many to do work illegally. As far as where the money comes from to add additional staff to facilitate license requests, I really don't care if I have to pay \$75 more dollars every two years to renew my license. But is that actually going to be enough to get the CCB back on track? 10 to 14 days used to be the amount of time given to fulfill a license request. That seems reasonable. But can the CCB deliver? Will my biyearly \$75 make that a reality? I'm not so sure. This issue needs to be fixed before any more faith in the CCB's ability to function adequately is eroded.

Bill Smith, Business/Organization: Parker Smith and Feek	Indeterminate	I am writing you this email to bring up an issue that does not look favorably on the CCB, especially with the proposed fee increases. The CCB wants to institute higher fees, yet the CCB service is lacking. I recently had numerous clients impacted by the CCB and their lack of the staff doing their job. With the recent \$5,000 increase (1/1/24) in the required CCB bond amounts for contractors, I had several clients where the CCB recognized the increase in the clients' residential bonds, yet the CCB didn't recognize the increase in the commercial bonds, despite getting a rider from the surety increasing the bond amount for both bonds. How can the CCB update one of the bonds yet ignore the other? This resulted in clients getting a notice from the CCB that they were out of compliance, when in fact they were not. In one case, a general contractor who was using one of my clients on one of their jobs, put the subcontractor on notice for noncompliance when in fact they were not out of compliance. The CCB did not do their job and created not only an embarrassing situation for my client but also could have ultimately cost them a project and lost revenues/profits. I would have instructed the client to sue the State for negligence. This is inexcusable being the CCB recognized the residential bond increases and not the commercial bond increases. In another situation, one of my clients was notified they were not incompliance with BOLI as their \$30,000 Public Works bond was not in force. Through investigation with the CCB, nouly did the CCB have all their licenses bonds in force for this client, but it was discovered the BOLI bond was in the hands of the CCB, but the staff didn't update the system. It was simply put in a file or wherever copies of bonds are stored at the State level. Again, this is inexcusable. I have been a surety professional for over 35 years both on the broker and surety company side of the business. I am appalled at the lack of professionalism and support by CCB recently who is not doing their job and yet

They almost always claimed "grey areas" in the building codes. In my 40= years as a contractor I have never had a claim filed against me with the CCB. I am afraid that your fee increase will force many small exempt contractors to leave their businesses which are probably just paying them just enough to stay in business. 		-Our small and family owned business also had to sign up for a BIN, (Department of Revenue) and I have no idea what that fee may be going forward. In fact, trying
		to sign up for and get assistance in that realm was an absolute nightmare and no one was available to answer questions or to ensure that I filled the paperwork out correctly!
		-Our small and family owned business also must put aside and save enough money to not only pay business and personal taxes, but also must pay the State and the
		Federal Government for withholding taxes for us, the business owners, and for our employees. This is in addition to: Oregon Partnership Minimum Tax; Oregon Pass Through Entity Tax; Oregon Corporate Excise and Income Tax; Withholding Tax; Unemployment Insurance Tax. As you can see, there is no shortage of taxes we
		must pay for the luxury of doing business in Oregon State. -Oregon requires that all Contractors must re-license every two years for the first 6 years in business. Why? I feel unless a Contractor has broken the rules or has many infractions, why should a compliant business have to re-license so often?
		-Oregon also mandates that in order to re-license, a Contractor must take continuing education classes that not only cost money that often goes directly to the
		State, but often the classes are not even geared towards one's industry or specific to one's trade. In fact, more often than not, the classes offered have nothing to
		do with one's license and everything to do with collecting yet another fee. If the CCB actually had classes geared towards one's industry, then continuing education would not only make sense, but it would be enjoyable to pursue. This is currently not the case.
		-Small businesses often foot the bill for other State Funded projects, such as transportation. Here in Lane County, our fee increased from \$800 a year, to \$1,200 a
		year for our LTD transit system, with no vote, voice or input of our own.

The work of the CCB is really not very dependent on the number of contractors — with computers and modern office technology and systems, managing 1,000 and 10,000 registrants isn't much different.
		What really determines the cost burden on CCB is your bad contractors who generate complaints — the contractors who don't communicate well, don't finish work, do shoddy work, etc.
		Therefore, I suggest you do NOT raise fees on all contractors; instead, CCB should hold steady or even reduce general registration fees, while starting or increasing a complaint processing fee on the contractors who get complaints.
		Just as the consumer has to pay \$50 to get a complaint processed, you should charge contractors who get complaints a processing fee sufficient to cover your budget shortfall.
		If you do it my way, the good contractors who do a good job and who impose essentially no burden on the CCB aren't hit with a fee increase and don't have to raise their prices. Instead, the contractors who provoke consumer complaints face an increased cost of doing business, which is an incentive for them to clean up their act.
		Even more importantly, if a contractor fails to pay a complaint processing fee, the complaining consumer should immediately be then allowed to proceed to court and have access to the non-appearing contractor's bond.

Restorations		I am fairly new to the contracting/trade world. My prior background/experience was in the IT/Technology industry with over 30 years experience.
		My overall experience with the CCB has been good. I have had some difficulty with the onboarding process and also with the suspension side of the CCB. My license was temporarily suspended due to me not showing proof of insurance in a timely manner. I had that decision reversed based on my feedback at the time and even saw a process change, allowing contractors more time to show insurance coverage.
		The CCB takes feedback well and implements positive change which is crucial to both the CCB, contractors and Oregonians who hire contractors. I appreciate this aspect of the CCB which is why I am sharing my perspective on the rate increase:
		I am absolutely 100% behind the fee increase! I feel that \$200 a year is a bargain considering the VAST amount of support, information, education and protection that the CCB brings to everyone.
		That said: My main pinch points with the CCB is communication. Early on, email was not considered a method for which to communicate with the CCB. So it was either a phone call, a fax or a visit to the office. When email became an option for communication, such as submitting proof of insurance, it seemed like a good thing however I learned that the CCB mail system was and likely still is broken. My example is that I submitted my proof of insurance via email as per instructions. When My license was suspended, I called the CCB and waited a stunning 1hr 45m to be told "we never received the email"
		Now remember: My background is in IT. So I was able to show proof that my insurance WAS delivered to a CCB mail server. This evidence was shared with CCB managers and this is where policy change came in to play.
		That's fine and all however: Waiting that long on the phone is unacceptable. I was told it was because the staff that handles the phone calls was severely limited. I get itstate run and allso with the fee increase, I STRONGLY urge the CCB committee to please consider more staff to handle more calls. I also urge the committee to please invest in a stronger IT infrastructure and ticketing system so that emails and tickets are tied together.
		My fear is that the increase will be squandered on other processes that have little impact. The BIGGEST impact will be to hire more staff. Yet that's typically the last thing executives want to spend the money on.

Now the state wants to push me to get an LCB license to plant trees after it pushed me out of LCB years ago. This is a problem for me, I do not want to get an LCB now. Sounds like a way for the state to squeeze more money out of me, it's a travesty! What's your take on this? ADDITIONAL INFORMATION: Follow-up with Chris: Chris, I hadn't thought to ask about accredited programs outside of CCB, so at your suggestion, just now was able to quickly find; Home - Institute of Door Dealer Education and Accreditation (dooreducation.com) I know of a young fellow that will need to get his own license soon, and I will direct him as you suggested and find specific courses related to our industry for approval through Don Myron. Thank you also for directing me to the Consumer Hotline, I have now bookmarked that site. More and more frequently I have customers relate to me an experience, or someone they know, having been charged wildly inflated prices for garage door repair. Nearly every homeowner will need garage door repair for some kind. Imagine for instance, a homeowner who finds their garage door is not working. They're in a panic because they can't get their car out. If they call the first number they find online, before you know it they'll have a story of their own of some flyby taking advantage of them. Such a scenario is typically due to a broken spring. A double wide door would usually have two springs, and both should be replaced. My company and most of my local competitors currently charge \$400 or so. Time and again I hear of the sam

# **CCB Funding Overview**

#### **CCB Revenue Breakdown**

- Contractor Licensing fees: 87%
- Civil penalties: 11%
  - 80% of civil penalties transfer to state General Fund.
- Miscellaneous income: 2%
  - Filing fees, change fees, admin and processing fees etc.

### CCB is a "Fee-for-Service" Agency

- Revenue/fees drive service delivery.
- CCB actively monitors and adjusts staffing, hiring service delivery based on actual and projected economic activity.
- We always look at ways to first adjust service, be more efficient, add tools to "do-more-with-less" first



### **Agency Structure**

### Licensing – 19 Staff (32% of staffing based on FTE)

- Process & screening new applications (350-400 monthly)
- Renew existing licensees (1,300 2,000 monthly)
- Update insurance and bonds (1,500 2,000 monthly)
- Customer Call center (350-500 calls daily)
- 75% Positive customer service satisfaction rating
- Improve service delivery to be more efficient
  - Email Reminders: more efficient, less cost
  - Online surveys: better response, real-time data

#### Field Investigation & Compliance – 16.5 staff (28% of staffing based on FTE)

- Identifying, investigating and stopping unlicensed work
  - Field investigators: 8K annual jobsite checks
  - Compliance officers: Consumer recovery and compliance
- CCB's enforcement program is
  - **Proactive** in the field daily trying to find unlicensed work
  - Statewide investigators across the state
  - Responsive reports followed up on in 24-48 hours
  - Efficient around 34 days to resolve cases
- Partnering to be more efficient:
  - Agreement for BCD license checks maximize resources
  - Expanding tools to address illegal online advertising
  - Cross-training field investigators to conduct mediations



#### **Dispute Resolution** – 7.5 FTE (13% of staffing based on FTE)

Mediate disputes between homeowners and contractors

- Voluntary program
- Alternative to costly and time-consuming court process
- Mediate approximately 1,000 disputes each year
- Pre-complaint mediation at contractor request
- 70% success rate if both parties participate
- Evolving Workforce to operate more efficiently
  - Cross-training staff to move process along more quickly
  - Moving to electronic communications



### **Consumer & Contractor Education** –

#### 4 Staff (7% of staffing based on FTE)

- Educate consumers about hiring licensed contractor, legal protections, best practices and avoiding scams
- 25-point increase in public awareness 78%
- Deliver contractor training on legal requirements, law changes and resources available for contractors
- Expanded information and resources available in Spanish for both consumers and contractors
- **Partnerships**: Key to delivering valuable resources & information
  - Avoiding disaster scams (DOJ, DFR and CCB)
  - Provide contractors a full regulatory picture (OSHA, DEQ, DFR)
  - Work with industry partners to share information for contractors



### **Administration and Central Services**

- Administration 4 Staff (7% of Staffing by FTE)
  - Directs agency consistent with mission, values and strategic priorities
  - Establishes and administers consistent policy through rulemaking
  - Coordinates human resource services for the agency
  - Processes public records requests and other state requirements
- Business Services 4 Staff (7% of Staffing by FTE)
  - Budget development and execution; ongoing revenue analysis and projections
  - Procurement, contract administration, cashiering, mail etc.
- Information Technology 4 Staff (7% of staffing by FTE)
  - Maintain and modernize IT infrastructure
  - Develop functionality that supports efficient service delivery



## **Fee-for-Service: Impact**

### How fees/revenue relate to service delivery

- Licensing
  - Processing time for license applications, renewals, license updates
  - Call center wait times delayed service on pending issues
- Field Investigations and compliance
  - Less field presence and fewer construction sites visited
  - Longer response time on reports of unlicensed work
- Dispute resolution
  - Complaint processing delays prolongs dispute for consumer and contractor
  - Maybe court becomes a more desirable path
- Education
  - Less consumer knowledge of importance of using licensed contractor
- Information Technology
  - Inability to invest in modernizing service
  - Prevents better, more efficient services



# What is Proposed?

- \$75 Increase to Contractor License Fee
  - Current Fee -- \$325 (Established in 2010)
  - New fee: \$400 for a two-year license
  - Implementation Timeline
    - Renewals -- Beginning July 2024 June 2026
    - New Applications Beginning July 2025

#### Current Proposal was selected

- Provided support for <u>existing service levels</u>
- Solidified the agency's capability to *modernize aging systems* 
  - Replace aging license system with a modern solution
    - Current system built in 1990
  - Provide better services and more efficient delivery



# Why Raise Fees?

#### Key Factors that board considered:

- Costs Increases: Labor cost inflation is up more than revenue
  - Since 2010 Labor costs are up 55%
  - Upshot: \$1.9M projected budget deficit
- Workload Demand: Industry has increased
  - Since 2010 14% increase in the number of licensees
  - Since 2013 32% increase in number of licensees
    - 2013 agency staffing was adjusted downward after impact of 2008 financial crisis
- Service levels have declined: Agency has not grown at all
  - 2010: 1 staff member to 550 contractors
  - 2024: 1 staff member to 847 contractors



### Why Raise Fees?

#### **Board's Critical Priorities: Ensure Financial Continuity and Stability**

- Address current structural budget deficit -- \$1.9M
- <u>Maintain</u> existing service levels
- Support IT modernization by replacing agency's aging license system (1990)



## **Alternatives?**

#### Alternatives Weighed Against Board's Critical Priorities

- Address current structural budget deficit -- \$1.9M
  - Cuts: Staffing would need to be reduced by an additional 10 positions
    - Result would be 1 staff member to 1,020 contractors
- <u>Maintain</u> existing service levels
  - Cuts: Additional cuts would further reduce service, responsiveness and effectiveness
    - 2010: 1 staff member to 550 contractors
    - 2024: 1 staff member to 847 contractors
- Support IT modernization by replacing agency's aging license system (1990)
  - Delaying IT modernization:
    - Risks critical failure
    - Holds agency back from providing better services more efficiently



### Summary

- Fees/revenue drive service delivery.
- Current revenue will not support existing service levels.
- Contractor fees have not been adjusted upward since 2010.
- Agency regularly adjusts to hold costs and maintain service.
- Agency faces critical priories of addressing cost increases, maintaining services and investing in IT modernization.
- Brass Tacks: Board determined that the increase was necessary to maintain adequate services and support modernization efforts.
