


#### **Foreword**

The purpose of this report is to provide the number and nature of asset forfeitures in Oregon in 2015. State and local government agencies electronically report seizures they have made for the purpose of civil and criminal forfeiture using the Oregon Online Grants System (OOGS). The staff at Oregon Criminal Justice Commission (CJC) uses the information reported by state and local agencies to compile this report for the Asset Forfeiture Oversight Advisory Committee (AFOAC). Statutory direction for the AFOAC, the CJC, and these reporting requirements are found at ORS 131.600, ORS 131A.450, & ORS 131A.455.

The Asset Forfeiture Committee met on March 28, 2016 to discuss the findings represented in the 2015 annual report. The committee noted that we continue to see a large disparity in the forfeiture proceeds between criminal and civil forfeitures.



The committee also remarked positively that the bulk of criminal seizures were pursuant to a court order via a search warrant or seizure order.



Finally, the committee discussed the notable absence of firearms in the forfeiture data. Pursuant to a relatively recent law change ORS 166.279 now makes the forfeiture of deadly weapons less cumbersome for law enforcement officials. However, unless the weapons are forfeited for proceeds under a civil forfeiture, and not destroyed or used for training purposes, they will not show up in this report. It is the belief of the AFOAC that the vast majority of firearms seized in Oregon are not forfeited for proceeds, thus explaining the notable lack of firearms data in this report.

#### **Asset Forfeiture Oversight Advisory Committee (AFOAC) Members**
