Per HB 4002 (2024), county applicants may not receive less than \$150,000, which will affect the actual percentage of funds distributed to counties.*

CJC staff are currently working with counties to inform the proportion of funds available to each applicant using the combined projections of potential populations served by the program. The Phase 2 funding formula table will be released later this year as part of the Phase 2 solicitation.

†††† According to House Bill 3069 (2025), 3% of funds (after funds for Tribal Governments have been set aside) shall be retained by the commission to support grant recipient data collection and analysis or evaluation of outcomes measures and 2% percent of the non-tribal funds shall be retained by the commission to support technical assistance for grant recipients.
