Oregon JAG Program > Oregon Innovation & Intervention Fund

- Federal pass-through funds from BJA/USDOJ; no match requirement and funding provided on a reimbursement basis
- Funding source is CJC's FY 24 JAG federal award (15PBJA-24-GG-04282-JAGX)
- Part of Oregon's Justice Assistance Grant (JAG) program administered by the CJC.
- Oregon's JAG Program is informed by the Oregon JAG Strategic Plan (2024-2029).

OIIF Overview

OIIF Definition

- **Improvement of Oregon's public safety system** in innovative ways
- **Direct response** to current public safety issues and crises
- Innovative projects that have a strong potential to positively impact public safety and benefit the entire state through **measurable outcomes** and **potential reproducibility** after a pilot period.

Total OIIF Allocation = \$1,500,000

- Required Variable Pass-Through Rate (VPT) to local government entities (LGEs) = \$984,806 (direct)
- Available for State entities and non-government entities = \$515,194 (direct pass-through)
- “Local Less than \$10k” = \$308,951 (must be benefitted, does not require direct pass-through)

OIIF Funding Priorities

Oregon CJC JAG Strategic Plan (2024-2029)

- Funding Priorities
 - Address **substance use disorders and mental health needs for justice-involved individuals**
 - Improve criminal justice decision making to emphasize data-driven decisions and evidence-based practices
- Goals
 - Improve criminal justice decision making to emphasize data-driven decisions and evidence-based practices regarding **community supervision and incarceration**.
 - **Reduce recidivism** by facilitating the successful reintegration of individuals into the community.
 - **Measure effectiveness** of programs, services, and policies through sound and relevant research.
 - Examine criminal justice policies to ensure fairness, consistency, proportionality and opportunity.

OIIF Funding Priorities, continued

BJA JAG Criminal Justice Program Areas

- Law enforcement
- Prosecution and courts
- Prevention and education
- Corrections and community corrections
- Drug treatment
- Planning, evaluation and technology improvement
- JAG statute defines criminal justice as “activities pertaining to crime prevention, control, or reduction or the enforcement of the criminal law”.
- Impact of President’s Executive Orders

Eligible Applicants

- Local law enforcement agencies (cities and counties)
- State law enforcement agencies
- Local government agencies (cities, counties, and public school districts)
- State government agencies
- Non-profit organizations
- Community organizations
- Institutions of higher education

- **Applicants must have a federal Unique Entity Identifier/UEI (see <https://sam.gov/entity-registration>)**
- **Applicants cannot be suspended or debarred from receiving Federal funding assistance.**

Solicitation Parameters

- Application deadline of February 13, 2026, 9:00 PST
- Minimum request of \$150,000; maximum of \$400,000
- Estimated grant/project performance period of July 1, 2026 to September 30, 2027
- Possibility of a one-year, no-cost extension to complete project activities, BUT . . .
- Permitted uses are personnel, fringe, travel/training, equipment, contractual services, consultants, 2nd tier subawards, supplies, administrative costs up to 10% and indirect costs
- Prohibited uses includes firearms, physical facility improvements, entertainment, food and drink (other than travel per diem), branding and promotion, etc. (see full list in RFGP and BJA JAG FAQs).
- One application per organization/Unique Entity Identifier (UEI)

Eligible Budget Categories and Costs

Grant program funds may be spent within the following BJA-approved budget categories:

- *Personnel:*
Salaries and wages for all grant-funded personnel, with itemization for requested overtime (overtime is subject to BJA approval).
- *Fringe Benefits:*
Fringe benefits for all grant-funded personnel (in whole or in part, as a percentage of salaries/wages if possible).
- *Travel/Training:*
Eligible expenses for transportation, lodging, and per diem for training/conferences that support grant purposes (GSA-based rates).
- *Equipment:*
Permanent or non-expendable equipment with a useful life of more than one year and a per-unit acquisition cost (or cost required to make the item operational) that equals or exceeds **\$10,000**.
- *Contractual Services:*
Organizations or entities providing goods, technical expertise or equipment to the Grant Recipient for purposes related to the project (typically performing defined tasks).
- *Consultants:*
An individual or firm who provides professional advice or services for an hourly fee, but not as an employee of the Grant Recipient. Consultant rates that exceed \$650/day or \$81.25/hour require prior BJA approval.

Eligible Budget Categories and Costs, continued

- *Subawards:*
Defined as organizations or entities responsible for part or all of the program objectives and subject to federal grant regulations.
- *Supplies:*
Consumable materials, including the cost of small items of equipment that do not meet the useful life or cost threshold for the “Equipment” category. **Itemization of supplies (unit cost, quantity) is required.**
- *Other:*
Other allowable expenses include participant support cost, meeting room rental space, training and conference fees
- *Indirect Costs:*
Indirect costs are permitted, either using the 15% de minimus rate or the rate identified in a federal agency approved Negotiated Indirect Cost Rate Agreement (NICRA). Indirect costs must not be attributable to any specific project and must adhere to the Modified Total Direct Costs (MTDC) calculation defined in 2 CFR 200.1.
- Administrative costs associated with grant management activities including reporting, subrecipient monitoring, subcontract management, purchasing, budgeting, and accounting **are limited to 10% of the total requested** and must be directly allocable to the proposed project (i.e., not part of the indirect cost pool).
 - Must be attributed to an BJA-approved budget line item such as personnel, fringe, travel, etc., and
 - Must be substantiated by supporting documentation to be eligible for reimbursement.

Prohibited Uses

- **Supplanting**
- Compensation of federal employees
- Land acquisition
- Physical facility improvements
- Employee bonuses
- Firearms or tactical equipment
- Polygraphs
- Marketing or branding
- Lobbying
- Fundraising or donations
- Taxes
- Fines and Penalties
- Entertainment (activities that can be classified as amusement or diversion)
- Food and drinks, except allowed as per diem in accordance with state/fed policies
- Catering
- Warranty services, agreements, contracts covering any period that extends beyond the project end date.


Required OIIF Application Components

- **Completed 2026 OIIF Application Template (Word)**
- **Budget Detailed Worksheet (BDW) or Excel/Word document with equivalent information**
 - Read through Budget Sheet Instructions tab for full definitions of cost categories.
(Ignore supplies threshold of \$5k, has since been revised to \$10k.)
 - See Budget Year 1 tab for required budget narrative elements for each cost category.



2026 Oregon Innovation and Intervention Fund (OIIF)

The Edward Byrne Memorial Justice Assistance Grant (JAG) Program serves as the primary federal source of criminal justice funding to state and local jurisdiction and is administered by the Bureau of Justice Assistance, a unit of the U.S. Department of Justice. As Oregon's State Administering Agency, the Criminal Justice Commission (CJC) manages the State's JAG program. To guide the program's funding priorities, CJC developed a comprehensive statewide JAG Strategic Plan for the timeframe of January 1, 2025-December 31, 2029.

The Oregon Innovation and Intervention Fund (OIIF) is one component of the State's JAG program and focuses on improving Oregon's public safety system in innovative ways, or as a direct response to a public safety crisis. Innovative projects are defined as having a strong potential to positively impact public safety and benefit the entire state through measurable outcomes or potential reproducibility after a pilot period.

OIIF Application Instructions

- Thoroughly review the RFGP, Application Template, BDW and Resources provided on the CJC website.
- Responses should be concise and specific. Please observe word count limits.
- Refer to pages 9-11 (Application Contents) of the RFGP for additional information on what is being required for narrative sections.
- Submit the application cover sheet and narrative as a Word document and the budget as an Excel spreadsheet (BDW preferred). The budget narrative may be submitted as either part of the Excel spreadsheet or as a separate Word document.
- Application packages must be submitted via email to cjc.grants@cjc.oregon.gov with “2026 OIIF Application Submittal” in the subject line by February 13, 2026, 9:00 P.M. PST.

Application Review Criteria

- *Problem Statement*
Does the problem statement identify a public safety issue or crisis? Does the proposed project address CJC JAG priorities and/or BJA JAG program objectives?
- *Program Design and Implementation*
Are objectives clear? Can the project realistically be done with existing and requested resources (budget, time and skills)? Is stakeholder collaboration and management addressed? Are resources effectively distributed for successful execution?
- *Organizational Capabilities and Competencies*
Does the organization have the appropriate background and experience to implement the proposed activities? How will gaps be addressed? Does the organization have prior experience with federal grants?
- *Plan for Collecting Required Data*
Does the proposal address tracking progress against project objectives? How does the organization ensure that data to measure success is collectable and accessible?
- *Budget and Detailed Budget Narrative*
Does the budget use BJA-approved budget categories and include the level of details required in the BJA Budget Detailed Worksheet? Are all proposed expenses allowable? Are administrative costs limited to 10% of total request and are they clearly identified in the budget narrative? Are supplies itemized in the narrative?
- *Local Government Entity (LGE) Pass-Through Requirement and Ensuring <\$10K LGEs are Addressed*
Does the project help CJC to meet the BJA LGE pass-through requirement and/or address how <\$10K LGEs will be benefitted?

March 16 – April 6, 2026	Applicant capacity review and presentation preparation for CJC Board of Commissioners
o/a April 7, 2026	Review by CJC Board of Commissioners
April – May 2026	BJA project review and approval
June 2026	Intent to Award and subaward execution
July 1, 2026	Performance and budget period start date
