Profile Reports

Profile reports are listings of the data contained in R*STARS profiles. These reports are intended to be used to proof profile data and as a reference when entering transactions. Note that a number of other sources exist to assist in selection of valid codes during transaction entry. Users can interrupt to profiles directly, or to these key selection screens:

77	Index Selection
78	Program Selection
79	Comptroller Object Selection
81	Agency Object Selection
3A	Vendor Alpha Inquiry
3N	Vendor Numeric Inquiry

For more information on these screens, see the R*STARS Data Entry Guide.

The following page presents a sample of the D10 Comptroller Object Profile screen and the DAFQD100 Profile Report. The profile report displays the same information contained in the profile screen. The profile report columns are presented in the same order as the fields are presented on the profile screen. For example, the first column on the DAFQD100 Profile Report, Appropriation Year, is the first element on the D10 profile. All other Profile Reports are consistent with this pattern. For this reason only a few examples of profile listing reports have not been included in the Report Guide. To understand how a given listing will appear, users can examine the profile screen on-line. Note the following requestable profile listing numbering convention:

PURPOSE:

This report provides a listing of R*STARS Comptroller General Ledger Accounts and the transaction codes that impact this general ledger account. It presents general ledger accounts in numeric order along with the title for the general ledger account. For each general ledger account, the transaction codes are listed with descriptions that affect this account (in numeric order). For more information about a given general ledger account, users can refer to the D31 Comptroller General Ledger Account Profile screen. For more information about a given transaction code, users can refer to the 28A Transaction Code Decision and 28B Transaction Code Description Profiles. R*STARS users should refer to this report to help select the correct transaction code to use when recording of a particular accounting event.

NOTE: TC's with Blank GL's

If a Transaction Code (28A) has a blank GL account (to be filled in from the choices of GL's listed on the 28B screen), that Transaction Code does not show on this report under the 28B GL account. This report only shows Transaction Code/GL account relationship if the GL account is in one of the four pairs of GLs on the 28A screen. **See Example below.**

TC191 has a debit to 0065 (Unreconciled Deposit) BUT the credit GL is left blank for the user to choose between the list of GL's on the 28B screen. GL 1225, 1235, 1575 - 1578, 1701 - 1703, 1711 - 1713 WILL NOT be on the DAFQA010 report; ONLY the 0065 will appear.
