WHO TO CONTACT WHEN YOU NEED HELP

Every agency has an assigned “Agency Support Analyst” (agency analyst). A current list of agency analyst assignments by agency can be found on the SFMA 90 profile screen in R*STARS Keyword – News Page 05. Your agency analyst is available for problem resolution for your agency. Each agency should attempt to solve the problem internally, using agency resources. If this is unsuccessful, the agency contact person should contact their assigned agency analyst for help.

Agency procedures should be made to provide individuals with answers to frequently asked questions. An agency analyst is there to resolve problems that cannot be solved with existing help that is already available to the user (e.g., on-line help, system documentation and agency documentation / procedures).

Agency analysts are available to provide additional assistance to all agency staff working in SFMA. In order to provide quick and uniform help to agencies, please make copies and screen prints of all problem areas. It is important to know that although anyone may contact SFMA, agencies should designate who should contact the agency analyst. This will ensure that each agency will develop their own internal experts on the system.

The agency analyst is your best resource for problems you encounter when entering transactions, corrections, balancing batches, report questions, etc. Questions relating to budget/allotments need to be directed to your BAM analyst. Questions relating to prior period adjustments, GASB 38, etc. should be directed to your SARS analyst. **IF YOU ARE UNSURE OF WHO TO CONTACT, YOUR AGENCY ANALYST WILL BE ABLE TO DIRECT YOUR CALL.**
