REPORT PURPOSE

OSPA produces these reports when OSPS runs an automated process to end (outdate) or start (indate) a specific type of deduction on the P070 Deductions and Deduction Adjustments screen. Depending upon the purpose, the report may list employees who had the given deduction and OSPA has outdated it or employees where OSPA has added the deduction.

The reports include:

- E560-04-01 List of YYYY Outdated CFD Deductions
- E560-04-02 List of In/Outdated Food Bank Deductions

We use the report to verify the accuracy of the in/outdate process and to avoid any overlap, gap, or duplicate entries for an employee.

REPORT FREQUENCY

The OSPS Systems Development Analyst requests this report whenever there is a statewide change of deductions. For example, we outdate Charitable Fund Drive (CFD) deductions in October and Governor's Food Drive (Food Bank) deductions in February of each year.

- EID Employee ID number, OR######
- DED TYPE -- Deduction code from the PTD1 Payroll Deduction Table screen
- DED PLAN Deduction plan code from the PTD2 Payroll Deduction Table screen
- CLASS -- Class number from the State's Classification Plan for the employee's position
- BEGIN DATE START DATE from the P070 Deductions and Deduction Adjustments screen, effective date for the deduction
- END DATE END DATE from the P070 screen, the last pay period the deduction will be in effect
