Letter of Agreement—12 Hour Shift Pilot (OSH)

2	This Agreement is between the State of Oregon, acting through its Department of Administrative
3	Services (Employer) on behalf of the Oregon State Hospital (Agency) and SEIU Local 503, OPEU
4	(Union).
5	
6	The purpose of this Agreement is to establish a <mark>OSH workgroup</mark> continue working negotiations
7	on the establishment of a 12 hour shift pilot for MTHs and LPNs. OSH believes moving to this
8	schedule will provide continuity of care, consistency of staffing, and aide recruitment efforts. This
9	pilot will allow OSH to determine if this type of schedule would benefit the hospital long term.
10	
11	For success and to implementation of this pilot, both AFSCME and SEIU have to agree to move to a
12	12-hour schedule. AFSCME has reached agreement on the 12- hour scheduling pilot. SEIU
13	needs additional time to work through the pilot proposal.
14	
15	The pilot project has a targeted implementation date will be during first quarter of 2026. <u>To meet</u>
16	that target implementation date, parties will schedule their first workgroup bargaining
17	meeting no later than July <mark>31</mark> , 2025.
18	
19	Before implementation, additional contractual language around the pilot may need to be
20	<mark>explored and</mark> formalized <mark>. <mark>If either party can not come to an a</mark>greement, they will not be</mark>
21	required to implement a 12-hour scheduling pilot.

23	Areas of discussion may include:
24	Pilot bidding – opting out/into the pilot unit
25	Shift options
26	o Three 12-hour shifts with an additional 4-hour shift each week (including 12-hour
27	relief pool).
28	 Three 12-hour shifts with the option to work an additional 1 hour 20 minutes to
29	create a 13 hour 20 minute shift (MHTs ONLY)
30	o Three 12-hour shifts per week and be employed at 0.9 FTE (employee choice)
31	o 8 hour bridge shift

32	Self-Scheduling model
33	The committeeNegotiations would be comprised of the labor bargaining teameight (8)
34	members, with four (4) members appointed by SEIU and four (4)an equal number of
35	management representatives. Additionally, DAS LRU manager and SEIU Representative
36	<mark>maywill participate, as needed. Committee</mark> Bargaining team members will be on paid status
37	during bargaining meetings and flexing of schedules will be allowed to avoid overtime.
38	
39	The committee will submit recommendations to the OSH Executive Team
40	
41	Bargaining will continue for an additional 90 days following the tentative agreement signature
42	date specific to this LOA.
