## **Policy Statement:**

As of September 14, 2020, the Executive Branch of state government modifies the Family and Medical Leave policy to include a definition of "Child Care Provider", "Closure" and "Intermittent Leave" as it relates to sick child leave under the Oregon Family and Leave Act in response to the public health emergency for the time period of September 14, 2020 through March 12, 2021.

## **Policy Amendments**

Effective September 14, 2020, Family and Medical Leave policy 60.000.15 is amended as follows:

## Definitions:

**Child Care Provider:** for the purpose of sick child leave during a statewide public health emergency declared by a public health official means a place of care or person who cares for a child. ¶

(a) A person who cares for a child includes but is not limited to individuals paid to provide child care, for example nannies, au pairs, and babysitters or individuals who provide child care at no cost and without a license on a regular basis, for example, grandparents, aunts, uncles, or neighbors.¶

(b) Place of care is a physical location in which care is provided for a child including but not limited to day care facilities, preschools, before and after school care programs, schools, homes, summer camps, summer enrichment programs, and respite care programs. The physical location does not have to be solely dedicated to such care.  $\P$ 

**Closure:** for the purpose of sick child leave during a statewide public health emergency declared by a public health official means a closure that is ongoing, intermittent, or recurring and restricts physical access to the child's school or child care provider.¶

(5)(d) For the purposes of OFLA, intermittent leave means leave taken in multiple blocks of time and/or requiring an altered or reduced work schedule including but not limited to sick child leave taken requiring an altered or reduced work schedule because the intermittent or recurring closure of a child's school or child care provider due to a statewide public health emergency declared by a public health official.¶
