#### **VENDOR OR PRODUCT SELECTION METHODOLOGY:**

Section 5.3 Contractor Selection Methodology describes the Best Value Analysis (BVA) process to use. Authorized Purchasers BVA may result in a selection based on various factors including cost, Services availability, time of performance, coaching experience and other factors. Authorized Purchasers must conduct the following BVA process:

- Review the Statement of Qualifications (SOQ) form provided by each Contractor for each available coach.
- If one or more Contractors (coaches) can meet the needs of the Authorized Purchaser, the Authorized Purchaser will reach out to each Contractor (coach) and conduct an interview (free 30-minute meet and greet offered by each Contractor) to determine who will best meet their needs.
- At the conclusion of the interviews, Authorized Purchaser will select a coach.

Mandatory Purchase Order Language is included on the sample Purchase Order (see Exhibit D).

### STATE AGENCY PURCHASE ORDER DELEGATION:

State agencies under the Department of Administrative Services ("DAS") procurement authority may issue ordering instruments (such as purchase orders or service order contracts) under these Price Agreements for any dollar amount without further delegation of procurement authority from DAS. See Section 5.4 of PA.

**LEGAL SUFFICIENCY REQUIREMENTS FOR STATE AGENCIES:** Authorized Purchaser must obtain DOJ legal sufficiency for any SOC's or POs over \$250,000.

#### **OREGONBUYS:**

The awarded Price Agreements, including all attachments, are posted on OregonBuys <a href="https://oregonbuys.gov/bso/">https://oregonbuys.gov/bso/</a>. Refer to each Price Agreement for attachments, including exhibits and any amendments and for any updated Buyers Guides.

Authorized Purchasers must post in OregonBuys the resulting Purchase Order or Service Order Contract (SOC) in OregonBuys.

Price Agreement exemptions under special circumstances: State Agencies under DAS authority may be exempted from a Mandatory Use Contract upon a request to and approval by the Contract Administrator of the Mandatory Use Contract. See OAR 125-247-0296
