Notes or special considerations

Initial testing of XML update revealed an issue with the fix for \$0 line items as it hindered ODF's ability to use their work around for Credit Memo processing. On Sept. 25 PHI applied a change to address this, selectively allowing \$0 lines if they are a credit memo line and suppressing \$0 if it is an invoice line. Testing by ODF started fresh after this update by sending three new batches.

Two successful batches of interface testing were performed from UAT to R*STARS Acceptance region in v15.6. One additional successful batch was performed on these XML changes after implementation of v15.7 to UAT.

*The v15.7 release includes defect fixes that could potentially impact the interface. Knowing this, Oregon will perform three rounds of interface batches to test the release. Per email 9/30/2020 from Liz Schultz, the SFMS group will only require reconciliation information be submitted for the latest 3 batches of the v15.7 testing in order to approve all of these updates (v15.7 and the two XML changes) for PROD migration.
