This applies to any single printed order, Purchase Order, Contract Release Order, or request submitted on Customer letterhead. Shipping charges if applicable will be listed on Customer Invoice.

4. <u>Product General Specifications</u>:

4.1 Ink: All Pantone® colors available. Metallic ink colors are additional charge (see

above). No Thermograph (raised printing), gold foil, or four-color process

available at this time.

4.2 Paper: White 24# Smooth Finish, #1 bond laser compatible. Alternate letterhead
