### Standard Practice - Risk Transfer & Insurance

### **Contracts for Services**

### Risk Transfer (Indemnity/Hold Harmless requirements):

Contractor shall defend (subject to ORS chapter 180) save, hold harmless, and indemnify the State of Oregon and Agency and their officers, employees and agents from and against all claims, suits, actions, losses, damages, liabilities, costs and expenses of any nature whatsoever, including attorneys fees, resulting from, arising out of, or relating to the activities of Contractor or its officers, employees, subcontractors, or agents under this agreement.

DASRM\_IndemnityLanguage\_and\_insuranceRequirement

Requirement applies to the contractor.

### Insurance:

- Applies to the contractor.
- Financial backing behind indemnity/hold harmless requirement.
