STEPS:

- 1.) Follow the Buy Decision to determine if a Oregon Forward Contractor can provide first-aid kits.
- 2.) Use the Oregon Forward Program page to determine availability.
- 3.) If available, proceed to use OregonBuys to obtain additional program details via additional resources such as the Buyers Guide.

STATE SERVICES

This Price Agreement is between the State of Oregon ("State"), acting by and through its Department of Administrative Services ("DAS") and Rockwest Training Company, Inc., an Oregon domestic nonprofit corporation, which is a Qualified Rehabilitation Facility ("Contractor").


RECITALS


The State has enacted legislation to encourage and assist disabled individuals to achieve maximum personal independence through useful, productive and gainful employment by assuring an expanded and constant market for sheltered workshop and activity center products and services, thereby enhancing the dignity and capacity of such disabled individuals for selfsupport and minimizing their dependence on welfare and need for costly institutionalization.


This legislation and the implementing rules Oregon Revised Statues (ORS) 279.835 to 279.855 and Oregon Administrative Rule (OAR) 125-055-0005 to 125-055-0045 provide that if any Public Agency intends to procure certain specified products or services, that Public Agency is required to procure such products or services from a qualified nonprofit agency for disabled individuals in accordance with rules adopted by, and at prices established by, the DAS.




