Key Updates

Modeling Progress and Preliminary Results

- Matthew outlined the status of the HCAS modeling:
 - Pavement factor analysis is complete, with updates already integrated into the model.
 - Bridge and project work type classifications by ODOT staff are ongoing, expected midweek.
 - Preliminary results will likely be delayed by one week, moving from December 13 to December 20, 2024.
- Discussion highlighted that this delay would not impact the final report deadline of January 17, 2025.

Preliminary results presented during the meeting exclude updated project costs,
with significant impacts expected once those are incorporated.

Lookback Study Findings

- The Lookback Study remains a priority topic:
 - The SRT seeks clarity on discrepancies between OSU and ECONorthwest findings, particularly on project omissions and non-project cost categories.
 - Matthew stressed the need for direct coordination with OSU to resolve issues and integrate findings into HCAS effectively.
 - Bob Russell reiterated that reconciling differences is critical to ensure accurate reporting to the legislature.
 - Mazen suggested a review of VMT forecast methods and proposed adjustments to improve alignment with fuel consumption projections.

Data Preparation Methods

- Sean Wallace and Matthew presented updates on refinements to data preparation:
 - Method A introduced enhanced vehicle classification using registration data and VIN decoding for vehicle power type.
 - Method B added weight classification improvements, addressing inaccuracies in self-reported weights.
 - These changes, while modest, have improved data accuracy and equity ratio calculations, particularly for vehicles in the 10,000 to 26,000-pound range.
 - The SRT was invited to review the methods and provide feedback before finalizing the approach.

Next Steps

Report and Timeline

- Preliminary results presentation moved to December 20, 2024, ensuring integration of updated project costs.
- Final report delivery remains on schedule for January 17, 2025.
