Ewe COVID-19 prokram mi tongeni anisuk non chok mochomochon fansoun mi pwan tongeni anisi ekkewe chon angang ra nom won quarantine ika ra akanamonuno pwokiten ewe COVID-19 ika ar ra mefi ekkewe sainen samwau iwe ra chok utiwitin repwe cheki inisir, nge rese pass ren ewe COVID-19 paid sick leave (ika rese tongeni repwe angei ar kewe paid time off ren COVID-19). Ekkewe aramas ir mi pass ika qualify iwe ir mi tongeni repwe angei ukukun \$120 iteiten ran nge epwe chok kauk an aa tori 10 ran (1,200 total) ren ewe ukukun fansoun remi nom won quarantine ika nomwonong non imw pwokiten ewe COVID-19.

- Kose kut ika aea ekkewe benefit seni ekkoch pwan COVID-19 prokram non Oregon ika ekkoch state.
- Kose apply ika or noum taropwen moni ren paid leave seni omw ewe angang non omw nomw won quarantine ika nomwonong non neniom, ren chowean ekkewe sick leave ika vacation leave.
- Omw ewe angang ese erenuk kopwe keuno me angang ika anomwuk won furlough.
- Kopwe ereni omw ewe angang pwe mi namot omw kopwene nomw won quarantine ika akanamonuno non neniom ewe.
- Kopwe chok tongeni claimini ew fansoun ren omw kopwe quarantine.
