Developmental screening questions help give an idea of how a child is learning, growing and meeting developmental marks. Developmental screening tools help tell if a child would benefit from testing or services to help with learning. # What Families Should Know about the Employment Related Day Care Program





Families may be able to get help with child care costs through the Employment Related Day Care (ERDC) program. You may qualify if you are employed or if you are employed and are going to school. After being approved for ERDC you may continue to get help with child care costs when searching for work after a job loss, during a medical leave or for military transitions.

# **Going to school**

If you are attending school and working less than 40 hours a week, you may qualify for help with child care costs during student hours as well as work hours.

- The hours you attend school cannot be more than the hours approved for work.
- You must be attending a school approved to get federal student aid.
- Schooling must be for improving work opportunities. This includes completing your degree, GED, certificate or other credential.

### **Work search**

If you experience a job loss or a short break in work, you may qualify for help with child care costs during work search hours. This will give you time to find a new job.

- You will not pay a copay during the work search time.
- Your ODHS child care hours will not change.
   You can continue to take your child(ren) to their child care provider.

### **Medical leave**

If you are no longer working due to medical conditions or are on maternity leave, you may qualify for help with child care costs during the leave

- You will not pay a copay during the medical leave time.
- Your ODHS child care hours will not change.
   You can continue to take your child(ren) to their child care provider.
- You may need to provide the following:
  - Proof of medical leave;
  - The type of illness or injury; and
  - How long the leave is expected to last.

## **Military transition**

When you return home after discharge from active duty in a military war zone, ERDC can help with child care costs during your transition.

# **Child Care Programs**

You can choose to use a child care program licensed with the state of Oregon. You may also be able to use a friend or relative. You can have more than one child care provider.

Your child care provider(s) will need to complete the listing process if you choose a provider who is not already an approved ODHS provider.
