Tribal Programs Spotlight: Cow Creek Early Childhood Education Programs

Jennifer Reid, Cow Creek Education Director

- Preschool-(name)
 - Serving 15-3-5 year olds.
 - Funded by Preschool Promise and ECF
 - Creative Curriculum
 - Claw Valley Farm welcomed for gardening
 - Cow Creek Healthy Living have food and cooking demonstrations.

- Water studies
- Fish and Fry program
- Aquarium set up in the classroom
- Expanding Horizons Youth Center
 - After School Program
 - Grades 3-12
 - Language and Culture component
 - Funded by Grow Your Own grant
- Myrtle Creek Tribal Pantry
 - Located as a hub for Tribal members not only to take their children for childcare and preschool, but also to take advantage of the tribal pantry.

Child Care Infrastructure Fund

Amber Faist and Mykel Johnson, Northwest Native Chamber

- Funded through Department of Early Learning and Care contract
- Provide technical assistance specifically for CCIF
- 50 million allocated in 2023 focusing on infrastructure (new construction, repairs, or property acquisition etc.
- Second round opened March 26 and closes on April 30.
- Working on longer timeline
- 30 day timeline is a major barrier
 - Jennifer Jackson: Turn around time for bids and tribal approval is nearly impossible.
- NWNC- advocated for 60 days.
 - Alyssa: Underscore that there will be a round three. There will absolutely be more funds available.
 - Paulina: We need to work with Business Oregon to really understand the need to takes the tribes, their situation, their needs and their priorities under consideration, especially when reviewing budgets and timelines
 - TJ: Warm Springs applied for round 1 as soon as they were made aware. We had one day to get all of the materials and application in. Timelines are a huge factor with tribes. There

- should already be a Tribal set-aside. Tribes should not have to compete with 700 other entities.
- o Sonya, Val, and Julie echo TJ's comments
- Alyssa has reached out to the Director and Deputy Director of Business Oregon to request a meeting. This will include a representative from the Governors office as well.
- There will be a round 3
- Award decisions will in made in June 2025.
- Round 1: 4 of 5 tribal applicants were awarded 10 million total.
