## **Child Care Infrastructure Fund**

#### Tribal Needs Assessment

- CCIF Round 2
  - Awardees should be notified by June 13<sup>th</sup>.
  - Scores will be published in the following weeks on the Business Oregon website
- CCIF Round 3
  - Expected to open late summer/early fall
- The Tribal Needs Assessment is informed by ongoing TA with Oregon Tribes and CCIF applications
- Includes visits to Cow Creek, Coquille, Grand Ronde, CTUIR, Warm Springs, and Klamath
- Draws from Tribal Survey responses and direct feedback
- Reflects lived experience, survey with permission
- Shared Goals and Visions
  - o Center culture, language and healing
  - Build place-based, identity-affirming spaces
  - o Provide whole-family, wraparound supports
  - Develop Tribal-led, community-rooted workforce
  - Serve both rural and urban Native Families
- Markers of progress and success
  - More Tribes accessing and managing funding
  - State systems reflect Tribal models and timelines
  - Stronger trust, co-governance, and shared accountability
  - Every Native child grows in culturally affirming care
- Tribal Child Care Profiles + Infrastructure Survey
  - All completed Tribal profiles are under review by Tribes
  - The Supplementary Tribal infrastructure survey is still open
  - Survey results will be included in final assessment
  - Final report submitted to DELC by June 30 and shared with all Tribes

# Tribal Early Learning Plan and Fund: Timeline and Legislative Updates

DELC's Budget Bill SB5514

- Passed out of Joint Ways and Means. \$2.6 million General Fund in our POP 101 for key operational positions.
  - Accountant 1 for accounts receivables
  - Accountant 2 for Provider Management Platform Invoicing
  - Accounting Tech for accounts payable
  - ISS 5 for Provider Management Platform Coordination
  - OPA 4 for Lead Data Steward
  - PA 3 for Preschool Promise Quality Assurance
  - PA 3 for Healthy Families Oregon Quality Assurance
  - Additional \$3.1 Million for Child Care Licensing
- Reductions
  - -\$35 million in reductions affecting
    - Early Childhood Equity Fund
    - Healthy Families Oregon
    - Parenting Education
    - Preschool Promise
    - Professional Learning
    - Program Supports
  - DELC is looking at ways to possibly absorb these reductions
- No new investments
  - Birth Through Five Literacy- \$10.3 million (Tribal set aside still exists at the amount awarded last biennium)
  - Dolly Parton's imagination Library-\$2.2 million
    - HB2811 makes statutory changes for Dolly Parton Imagination Library. In Education Sub-committee of Ways and Means
  - Infant Early Childhood Mental Health Consultation-\$4.35 million
  - Tribal Early Learning Fund-\$4.75 million
    - HB 2815 passed, but without additional funding
    - There is a proposal that Tribes received at G2G that they may take forward should they choose to pursue, which would be restoring the 700k of 21-23 PDG funds. This was \$700k
    - DELC is not able to advocate
    - Press release following floor votes
- 2025-2027 Funding
  - Shift from needs-based funding approach to equal distribution
    - Tribes support
  - Due to lower funding amounts (45.1M vs \$0.7M)

- \$0.7M Tribal Hub current service level funding will become Tribal Early Learning Funds (pending passage)
- \$664,922 or \$73,880 per Tribe
- Tribes could propose End of Session Omnibus Bill/Proposal to Legislature

## **OTELLA: TELP & Fund What's next-Tentative**

- June 2025
  - Final month of session and estimated passage of Tribal Early Learning Plan Bill and fund appropriation
    - Finalize funding distribution
    - Send OTELA appointment requests for Tribes
- July 2025
  - New biennium begins July 1
    - New IGA's send (4 year agreements)
- July-August 2025
  - Send and Receive OTELA appointments from Tribes
    - Scheduling survey
- September 2025
  - Scheduling bi-monthly (TBD)
