Employment Related Day Care Provider Guide Insert



This Provider Guide Insert outlines increases to the Employment Related Day Care (ERDC) child care provider rates effective January 1, 2026. This insert also includes information regarding the Enhanced Rate, a new link to apply for the Enhanced Rate, and the previously shared update to the ERDC 9% Additional Payment form and request process that took effect January 1, 2024.

• Important note: Rates for license-exempt Family (FAM) and Enhanced Family (QFM) providers did not increase. Watch for an upcoming communication with updated rates once they are finalized. The rate increases in this insert apply only to centers (CNT, QEC, and NQC) and licensed family child care providers (RFM and CFM).

ERDC maximum rate increases effective January 1, 2026

- The new rates apply to child care provided in the month of January 2026 and later.
- Providers cannot bill ERDC families more than they charge private pay families.
- Reminder that ERDC cannot cover private school tuition.

Infant	Newborn through 11 months for license-exempt care 6 weeks through 23 months for Registered or Certified Family care							
Toddler	1 year (12 months) through age 2 years for license-exempt care 2 years for Registered or Certified Family care							
Preschool	3 years through 5 years for license-exempt and licensed care							
School	6 years or older for license-exempt and licensed care							
Special Needs	A child from newborn through 18 years old who needs more costly care due to a physical, behavioral, or mental disability							

Note: Unless the child has a special circumstance, ERDC pays child care for children through age 12. Children will remain on the billing form through the end of the certification period when they turn 13.

Enhanced Rates

The enhanced rate is a higher payment rate for license-exempt ERDC providers. They are eligible to receive an enhanced rate if they are enrolled in the Oregon Registry. Providers can enroll in the Oregon Registry by creating an account and completing required trainings. These trainings are tracked in the provider's account. My Oregon Registry Online (myORO) is a professional development platform for early childhood professionals, including child care providers.

To qualify for the enhanced rate:

- Complete the required trainings:
 - Recognizing and Reporting Child Abuse and Neglect (RRCAN)
 - Intro to Child Care Health & Safety (ICCHS)
 - Infant and Child CPR and First Aid
 - Oregon Food Handler certification
- Create an account on myORO and submit proof of completed trainings at https://my.oregonregistryonline.org
- Fill out an Enhanced Rate Program application: www.pdx.edu/education-career-development/ oregon-registry-educators.

Additional payment for ERDC payments that are processed late

As of January 1, 2024, ERDC pays an additional 9% for payments that is processed late. A payment is considered late under the following conditions:

- For Home-Based Providers: A payment is considered late when a legible and complete billing form is processed more than four business days after it was received by the Direct Pay Unit (DPU).
- For Center-Based Providers: A payment is considered late when a legible and complete billing form is processed more than seven business days after it was received by DPU.

If you believe you meet the above criteria, you may submit a request using the form found on the Department of Early Learning and Care (DELC) website: https://www.oregon.gov/delc/providers/pages/erdc-providers.aspx

Requests must be made within 30 days of receiving the payment. Once the request has been reviewed, DPU will determine if a payment was issued late and the additional payment can be made. Payment will be made in the same manner as the provider receives their regular ERDC payments, by check or direct deposit.

As of **November 2024**, there are now three options for submitting the request, and an attestation has been added to the 9% Additional Payment request form to indicate who is completing the form.

Options:

- Providers may request the additional payment for themselves
- Providers may request support from DPU to submit the additional payment request

- Licensed Family child care providers (Certified Family or Registered Family providers) may request support from their Union to submit the additional payment request.
 - of If you are a licensed family child care provider, and have questions about your Union rights related to the Additional 9% Payment, including the right to have the Union submit the claim on your behalf, to file a grievance, or your Union right to grieve if your claim for Additional 9% Payment is denied, you may contact your Union representatives at oregonccpt132.stewards@gmail.com.
