Oregon E-Cycles 2024 Tier Assignments

As of May 1, 2024

Below are the 2024 registration fee tier assignments for manufacturers in the Oregon E-Cycles Program. DEQ determines manufacturers' tier assignments annually. A manufacturer's fee tier determines the registration fee it pays and is based on its market share of computers, monitors, printers and televisions sold in or into Oregon the previous calendar year or four quarters (Q4/2022 – Q3/2023).

All manufacturers within a tier pay the same registration fee for a given year. Registration fees range from a maximum of \$35,000 for the largest manufacturers in Tier 1, to a minimum of \$40 for the smallest manufacturers in Tier 7.
