



Installation instructions for 12" & 20" D-Box

- 1. Carefully cut out required opening in the box with a knife.
- 2. Install seal from INSIDE the box.
- 3. Screw on the nut from OUTSIDE the box.
- 4. Tighten to provide a watertight seal.
- Remove the correct size tear out on the seal. TEAR OUT- DO NOT CUT OUT.
- 6. Slide the pipe into the seal.
- Snap the stabilizing feet into the sockets at the base of the box. (12" only)

Special Instructions for Installing 4" Corrugated Pipe Only

- Remove the 4" TEAR OUT on the seal. TEAR OUT, DO NOT CUT OUT.
- Carefully cut between raised ribs on back of seal in all 4 places.
- 3. Push corrugated pipe into seal.







AQUA SAFE®: Directions for Collecting Samples (Oregon version)

Sample Port:

A suitable sampling port can be constructed from a pre-fabricated container that is constructed from watertight material, with watertight joints. A standard distribution box can be used for this purpose provided:

- (1) It has a minimum diameter of 8 inches at the point of sample collection;
- (2) The inlet is at least 8 inches above the bottom of the sample port; and,
- (3) There is at least 2 inches of fall between the inlet and outlet of the sample port.

Directions for Collecting Sample:

Note: On installations that have an effluent dosing tank following the Aqua Safe, the sample can be collected from the Aqua Safe discharge as it flows into the pump tank.

- Using a dipper or suction device, remove the water from the bottom of the sample port
- Using a clean cloth or paper towel, clean the inside of the inlet pipe to remove any scum or debris that might have collected on the interior of the pipe
- Turn on a faucet or activate the dosing pumps to cause water to flow through the treatment plant (<5gpm), generating a flow into the sample port or into the effluent dosing tank.
- Allow the water to run for 30-60 seconds, and then collect a sample from the free falling stream running into the sample port or dosing tank. <u>Do not collect the sample from the stagnant water</u> <u>from inside the sample port.</u>

Valve Located Within the Pump Discharge (Pressure) Piping:


On certain Aqua Safe® systems that utilize an effluent pump, a valve is installed on the pressure line in location that allows for the collection of a sample of the pumped effluent. In these instances, samples should be collected in the following manner:

- Make sure that there is sufficient water (effluent) in the pump chamber to allow for a sample to be collected.
- Raise the pump float to activate the pump.
- Slowly open the valve and allow for the discharge to run for 1-20 seconde in order to clear any debris from the pump discharge line.
- Reduce the volume of the effluent flow by partially closing the valve.
- Place the sample container under the effluent flow in order to collect the sample.
- After collecting the sample, close the valve completely and lower the pump float.

Field Wiring Diagram








Field Wiring Diagram
