State of Oregon Department of Environmental Quality The following table includes greenhouse gas emissions information in metric tons of carbon dioxide equivalents (mtCO2e)¹ for Oregon facilities with an air quality permit. This document reflects each facility's direct emissions that occurred during the 2016 calendar year as reported to the Oregon Department of Environmental Quality (DEQ) or Lane Regional Air Protection Agency (LRAPA) for facilities in Lane County.²

Please note that this table contains similar – but not identical – emissions data as a document DEQ has published that shows emissions from many of the same facilities that could be potentially regulated under a cap-and-trade program that is being considered by Oregon Legislature. This table shows all emissions reported by facilities to DEQ and LRAPA, whereas only some of these emissions at some of these facilities would likely be directly regulated under a potential cap-and-trade program in Oregon.
