The purpose of the NPDES Permit Program Enhancement Report is to provide an evaluation of DEQ's organization, permitting procedures, permitting resources, and training, and identify and prioritize potential enhancements that will maximize DEQ's potential to achieve their permit issuance goals.

DEQ will use this report as a guide for program improvements. The NPDES Permit Program Enhancement Report is a recent companion piece to the <u>Recommendations and Implementation Plan</u> published December 2016 (Chapters 5 and 6).

- DEQ to communicate with permittees about permit template changes. The method for this communication is being discussed internally and DEQ is open to suggestions from roundtable attendees.
- DEQ could select drafts of IMDs to review with future roundtable attendees for input.
- Recommendation for DEQ to talk with permittees one to two years prior to permit renewal about recent additions to the permit template, and the history of the permit, especially in the case of individuals that may not have been the contact for the most recent permit.
- Support and develop expertise in the Legislature about TMDL issues.
- Support an integrated work plan for standards, TMDLs, other permitting efforts.
- Address issues with using variances for mercury TMDLs.
- Recommendation to prioritize water quality standard attainability.
- Provide Water Quality fees in the context of Land Quality and Air Quality, and be more explicit about the Water Quality fee impacts on program work.
  - Heightened concerns amongst some stakeholders about potential for the general fund/permit fee (called other fund) split to be altered through legislative process. Recognize that there may be need at some point in the future to revisit this, but should be done so in open and transparent manner as part of broader discussions.
- Discuss changes in the General Fund in relation to increasing fees.
