Your DEQ Online Modernization Project

We continue to streamline the way we accept, process and share information at DEQ. This is an important improvement to the way we do business, both internally and with the public. Our new environmental data management system, called **Your DEQ Online**, provides an easy and intuitive way to connect to DEQ.

Many of DEQ's regulatory programs have made this change and more are preparing to do the same. Our goals for **Your DEQ Online** are:

- To make our services more accessible to our stakeholders and the public
- To save applicants time and resources on application submissions
- To streamline DEQ processes and reduce the ongoing costs of collecting and maintaining submission data
- To provide more transparency in issuing permits, licenses and certificates
- To meet federal electronic reporting standards
- To improve access to publicly available environmental data

Ultimately, Your DEQ Online will make it easier for Oregonians to work with DEQ.

Submittals

Submit reporting, applications or renewals for permits, licenses, certifications, and reporting obligations.

E-Payments

Pay invoices, fees, penalties, and other payments online using an e-check or credit card. **Fact sheet:** [Payment options](#)

Dashboard

Check the status of projects, upcoming reporting obligations, permit/license/certificate renewal dates, scheduled inspections, pay invoices online, and correspond with DEQ.

Public records

Easily access records such as published submittals, permits, licenses, certificates, site projects and other public information.

Project Management

DEQ is working with the Office of the State Chief Information Officer, Enterprise Information Systems and other state agencies to ensure compliance with all requirements associated with major technology projects.

DEQ relies on a steering committee and expert work groups across the state in our Air, Land and Water Quality divisions to implement the new system for many DEQ programs. DEQ has also been involving members of the public and regulated community.
