# **Oregon Zero-Emission Fueling Infrastructure Grant Program 2025 Awardees**

In fall 2025, Oregon DEQ received 16 applications for the Oregon Zero-Emission Fueling Infrastructure Grant program, totaling nearly \$3 million in requests. Staff reviews and award decisions are based on making the most of diesel emissions reductions in Oregon among populations facing an inequitable burden of diesel pollution. Also, all applicable federal guidelines governing each source of revenue are reviewed. Of those requests, DEQ will fund 13 medium- and heavy-duty charging infrastructure projects in Oregon, totaling \$2,595,951 in awards.
