

Air Toxics Science Advisory Committee Meetings #5-7: Discussion of TRV Proposals

The Oregon Department of Environmental Quality (DEQ) and Oregon Health Authority (OHA) are currently reviewing the inhalation toxicity reference values (TRVs) used in DEQ's air quality programs.

At these meetings, the agencies will facilitate ATSAC discussions on the overall TRV update process as well as specific TRV proposals. Meetings #5-7 are scheduled within a two-week period with a common agenda. The ATSAC discussion in meetings #6 and #7 will pick up wherever the discussion left off in the previous meeting. **ATSAC members are expected to review the materials presented in [meeting #4](#) to prepare for meetings #5-7.**
