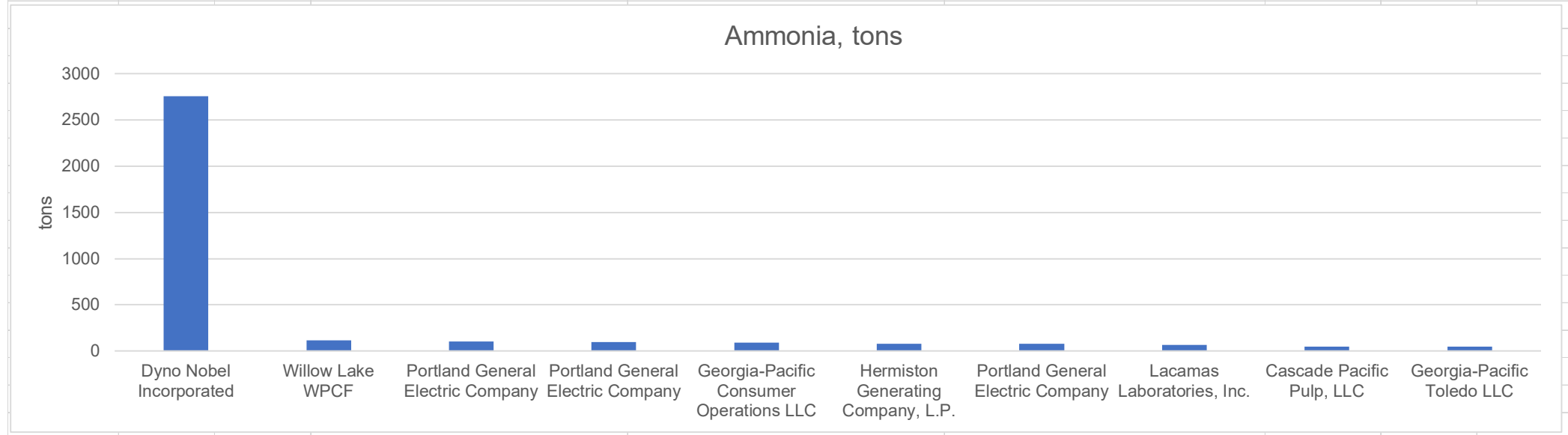

*EPA supplements airport emissions with modeled emissions estimates for airport activity.

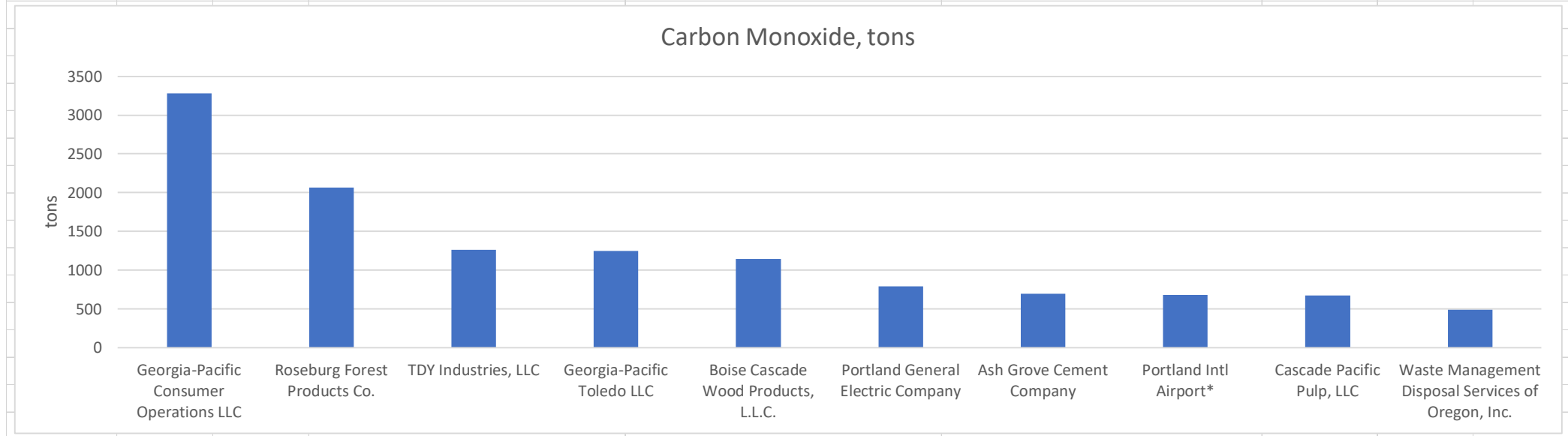
