Bison is anticipating complete lab results from Chester LabNet on May 24, 2023. I have been in communication with Paul Duda at Chester; he has sent us one batch of preliminary data, and I am expecting another batch of preliminary data, hopefully tomorrow (5/19) late afternoon. I spoke with Paul on May 10, and I thought he said we would have results on Wednesday, May 17. This was a misunderstanding on my part - I spoke with Paul again yesterday (5/17) and he said they expected to have final results to us on May 24, 2023, **if all goes well**. Due to the "if all goes well" caveat, and with the amount of data we are expecting to receive from the lab, we feel that we will be unable to deliver a quality report with sufficient time to complete our internal QA/QC process, and allow the client reasonable time for review and comment by the current due date of May 26, 2023. We propose an extension of the submittal date to June 9, 2023 (2 week extension) to allow sufficient time to ensure an accurate, high-quality report.
