DEQ has completed its review of the Cleaner Air Oregon (CAO) Emissions Inventory (EI), Modeling Protocol, Risk Assessment Work Plan, and Level 3 Risk Assessment (Assessment) submitted by Ramboll, Inc. on behalf of SI PORL2, LLC (Source Number: 34-0245) in accordance with OAR 340-245-0050(2). The EI was received on October 9, 2020 and revised on January 14, 2021, March 15, 2021, and April 2, 2021. The Modeling Protocol and Risk Assessment Work Plan was received on October 9, 2020 and revised on December 15, 2020, March 15, 2021, and April 2, 2021. The Assessment was received on March 15, 2021 and revised on April 2, 2021. DEQ approves the revised submittals and concludes the Assessment is complete and satisfies the CAO requirements for performing a risk assessment pursuant to OAR 340-245-0050.

The resulting residential excess cancer risk of 9, as determined by the Assessment for this facility, is above the Community Engagement Risk Action Level (RAL). The nonresidential worker excess cancer risk of 0.5, rounded to 1 and the acute risk of 0.96, rounded to 1, as determined by the Assessment for this facility, is above the Source Permit Level (SPL) of 0.5 for new sources [OAR 340-245-8010, Table 1]. All other risk values reported for this facility are below the SPL.

The next step in the CAO process is for DEQ to determine the level of community engagement required. Once DEQ makes this determination, additional guidance and timelines will be provided, including applicable CAO Specific Activity fees.
