Re: Submittal of Cleaner Air Oregon Emissions Inventory and Supplemental Materials

Dear Julia DeGagne:

By letter dated January 10, 2022, the Oregon Department of Environmental Quality (DEQ) provided written notice to Hollingsworth & Vose Fiber Company (H&V Fiber) that the facility located at 1115 S.E. Crystal Lake Drive, PO Box E, Corvallis, Oregon 97339 (the facility) was being called in to the Cleaner Air Oregon (CAO) permitting program. Per Oregon Administrative Rule 340-245-0030(3)(a), the first step of the CAO permitting process is to submit an emissions inventory no later than 90 days after receiving the written notice from the DEQ.

H&V Fiber is pleased to submit this timely CAO emissions inventory to the DEQ for review and approval. As requested, the CAO emissions inventory AQ520 form, containing estimates of each toxic air contaminant emitted by the facility, is being provided electronically along with this letter. H&V Fiber also prepared the following attached supporting materials to assist the DEQ during their review process:

- Attachment A—Emissions Inventory
- Attachment B—Source Test Reports
- Attachment C—Remediation System Schematic and Analytical Reports
- Attachment D—Miscellaneous Safety Data Sheets

A comprehensive emissions inventory is presented in Attachment A. The comprehensive emissions inventory presents detailed emission estimate calculations, methodologies, and citations to supplement the AQ520 form submittal. Attachment B presents the Ceramic Filtration Unit source test reports from 2018 that serve as the basis for toxic air contaminant emissions estimates from glass fiber manufacturing at the facility. Note these source test reports were previously provided to the DEQ for review.

Attachment C presents a general schematic of the remediation system and multiple analytical laboratory reports from ongoing sampling conducted at various stages in the treatment process. Attachment D includes safety data sheets for raw materials and cooling tower biocides utilized at the facility.
